The 1989 C.A. World Service Conference

hat makes the C.A. World Service Conference tick? Hard work, fierce conviction, tenacity, endless patience and an undaunted loyalty to C.A. and its principles. This is the stuff of which a C.A. World Service Conference Delegate is made. Over 90 of these dedicated members representing at least thirty states and two countries, convened at the Stouffer Concourse Hotel in Los Angeles last August 22 to complete the work of the Fifth Annual CAWSC.

And what, exactly, is that work? The Conference is a yearly gathering of national elected delegates, Board of Trustee members, WSO Board of Directors, and Conference Officers who serve as the governing and policy-making body of Cocaine Anonymous. This 5-day event sets the policies, rules and regulations by which each and every officially sanctioned C.A. meeting and group functions. The Conference is conducted democratically under parliamentary procedure by the elected Conference Officers. Presiding at the 1989 assembly were chairperson, Lucy S., Conference Secretary Debbie B., and the official Conference Parliamentarian P. Clay V.

The main body of work accomplished at a Conference is divided into seven classifications which are

represented by separate committees: Structure & By-Laws, Finance, CAWS Conference, Literature & Chips, CAWS Convention, Hospitals & Institutions and Public Information. Each committee works diligently throughout the previous year to establish the motions which are presented on the conference floor.

Among the other Conference tasks at hand are trustee reports, committee reports, nominations for new trustees, election of new officers, approval of new areas (the most hotly debated issue this year), and intensive committee work which eventually results in adop-

tion of new C.A. policies. In short, the CAWSC molds our fellowship.

Funding for the WSC is provided by the C.A. fellowship through profits made at the World Service Convention. Last summer's Convention held in New York City provided the WSO with well over \$37,000 to fund future conferences. Although the venue and accommodations are provided for WSC Delegates, they are responsible for travel and expenses.

The work completed at each WSC is essential to the growth and coherence of our C.A. Fellowship. All those who so loyally and lovingly participate in this endeavor are to be commended. Without their efforts, C.A. would not be the successful organization it is today.

This issue of The NewsGram contains several articles dealing with specific WSC Committees and their accomplishments at the 1989 World Service Conference. Those committees not represented in this issue — Finance, Structure & By-Laws, and Convention — will be covered in our next issue.

(Continued from page 1) C.A. carries the message through different media. P.I. continued this illustrative tradition by introducing new public service announcements and clarifying the guidelines of how Public Information is used. They also reported on the impact of a letter submitted to the Ann Landers column which had been answered by the WSO Public Information Office Committee.

Underlying P.I.'s report to the Conference was the sole objective of C.A.'s existence: To carry the message to the suffering addict. Always taking great care in personal anonymity, the P.I. Committee offered the message of hope, strength and courage to both the addict and those who may be interested in his problems.

Our experience should be made

available freely to all who express sincere interest. To that end, a motion was carried to translate all Starter Kit literature into Spanish in order to better serve the growing population of non-English-speaking C.A. members.

We believe further that our efforts in this field should always reflect our gratitude for the gift of sobriety and our awareness that many outside C.A. are equally concerned with the serious problem of addiction. Hence conference-approved C.A. PUblic Service Announcements are currently in the process of being copyrighted. Over the past year P.I. has created and approved five standard letters which all contained conference approved literature to respond to various inquiries

C.A. To Form New Support Group

would like to take this opportunity to share with you a new and exciting group that we at the C.A. World Service office are trying to implement: The C.A. Loner's Group. This group would consist of the following:

- People in remote places where a C.A. meeting is not available (loners).
- 2. People who are not capable of leaving their homes to attend meetings (homers).
- 3. Seafaring or traveling members of the fellowship (internationalists).
- 4. People currently involved in an active fellowship who are willing to correspond with these people and share their experience, strength and hope (loner sponsors).

Ideally, we would have four separate directories containing the names and addresses of participants in each Loner's group. We also plan to publish a bi-monthly "meeting in the mail" that contains letters from Loners, a list of newcomer names and addresses and other items of interest pertinent to this concept. The publication and updated directories would be sent on a regular basis to all participating Loners and Loner Sponsors, enabling efficient distribution of material as well as personal correspondence.

The C.A. Loner's Group will reach out to the members of our fellowship who do not have the privilege of attending regular meetings. Since this is a large and ambitious project, we welcome all your support. The C.A. World Service Office has already received three requests from "Loners": One is living in Saudi Arabia and the other two are incarcerated. As this fellowship continues to grow, hundreds of loners are going to need our support. If you would like to have tremendous impact on another person as well as the fellowship in general, here's your opportunity!

I will keep you posted on the development of this group through the NewsGram. If you have any suggestions or wish to contact me in order to be of service, feel free to call at the World Service Office at any time.

In my perception of the twelve traditions, I will try to explain. I feel that sporting C.A. T-shirts, hats or buttons does not promote our common welfare. In the past, the T-shirts and hats have caused a lot of animosity in the fellowship, therefore causing great turmoil—not unity.

In Tradition 4 it says, "Each group should remain autonomous except in matters affecting other groups or C.A. as a whole." I share the opinion that the buttons, T-shirts and hats affect C.A. and its members in breaking personal anonymity to the public. If I have "C.A." stamped all over my body, everything I do — good or bad — will reflect directly upon C.A. as a whole.

I feel that we are being diverted from our primary purpose by sitting around figuring out what to do about making money or looking at our buttons, T-shirts and hats. This is against the suggestions of Tradition 6.

The 7th Tradition states that we are to be fully self-supporting. Is making money with these items being self-supporting? Are we not exploiting the name of C.A.?

If I'm wearing any or all three of the objects I've spoken about, wouldn't this mean that any time I'm in public and I'm in conflict with anyone for any reason, I would be drawing the C.A. name into public controversy talked about in Tradition 10?

In Tradition 11, the "12 & 12" talks about attraction, rather than promotion, and needing to always maintain personal anonymity. Isn"t this also needed to humble ourselves rather than to say, "Look at me — see what I'm doing for me"? Does this keep us from self-seeking and personal ambition or an "I'm better than you" attitude?

"Anonymity is the spiritual foundation of all our traditions, ever reminding us to place principles before personalities," states Tradition 12. I always thought I was the most important person in the world and everyone should know it. I was told that I had to learn humility in my life and lose my ego. Wearing a hat, badge or T-shirt announcing, "Hey, I'm in C.A." — isn't this looking for praise? I've been taught to seek no

recognition or rewards for my service. Isn't having a badge announcing "I'm a recovering addict' building pride or ego? What happens if I get into trouble or get high? The only things people will remember is the C.A. on my chest or head.

To put it simply, the last line of the "12 & 12" says, "We are sure that humility, expressed by anonymity, is the greatest safeguard that Cocaine Anonymous can ever have."

I wrote this letter because, as a member of C.A., I have a great concern in what happens. I claim no authority for the fellowship and am writing on my own behalf.

I am only one of many who feel this fellowship has saved my butt. I write this for my own personal serenity. I would be grateful for any feedback given. I would also appreciate any suggestions you have for our Area Inter-Group.

C.A. Big Book In Progress

Literature Committee Makes Much Progress

nce again, it would appear that our Literature Committee has gone beyond the call of duty, considering the wealth of its motions passed at the World Service Conference. For starters, and of particular importance for addicts with 12 to 24 months of sobriety, is the newly approved 18-month chip. Its color will be black. As one wag put it: "I find it hard to share anyway and after my first birthday I thought I had a reprieve for the next 12 months. I guess it wasn't meant to be." A friend replied: "God works your program for you in mysterious ways." In fact, many addicts will be grateful for the introduction of the chip, a sort of pat on the back halfway through the second year.

Yet another signpost that C.A. has transcended its grassroots beginnings became evident at WSC. The WSC body approved that all C.A. Starter Kits be translated into French and Spanish. In the near future, French- and Spanish-reading addicts will be able to peruse: How It Works; 12 Steps, 12 Traditions, Preamble, Formats, Who Is an Addict?, A Vision for You, Promises, Higher Power, Tools of Recovery, To the Newcomer, The First 30 Days, Sponsorship, 23 Questions, Tips and the 70/30 Plan.

Regarding two pieces of soft literature, minor amendments were made to the "Higher Power" leaflet and the "Tips for Staying Clean and Sober" pocket card.

Of course, the motion that has most members of C.A. talking today has to do with our own Big Book. While a motion was passed agreeing that the books "Alcoholics Anonymous" and "12 Steps and 12 Traditions" were two of our most valuable tools of recovery and thus should be made available to support C.A. members in their recovery, the WSC agreed that Cocaine Anonymous should develop its own version of the Big Book. Of course, C.A. will continue to utilize the recovery portion of the Big Book of Alcoholics Anonymous; however, the C.A. Literature Committee has been charged with compiling a series of stories from addicts that will be published eventually in a book of cocaine-recovery stories.

While the project may take considerable time to complete, the committee has created a schematic for submissions. In October, 1989, the critical path calls for the creation of general guidelines and release forms for writers and local editors/agents. In November the guidelines and release forms were scheduled to be sent to members through the various C.A. publications and editor/agents. At that time, local editor/agents were to seek out candidates for storytellers who will tell their stories. If authors have problems writing their own stories, tapings will be arranged. By late spring, 1990, drafts and/or tapes or transcriptions will be sent to the C.A. Book Selection Committee. After the selections have been made, they will be forwarded to the **Book Committee Editorial Board** who will select the drafts for possible inclusion in the book. At this point, if the need arises, professional editorial help will be sought.

At this time, no date has been set for publishing our own book. For those interested in submitting their stories for consideration, release forms can be found in this NewsGram.

As is apparent, a tremendous amount of work has been done by members of the Literature Committee, chaired by Alan S., and they are all to be commended for furthering the principles of Cocaine Anonymous.

rguably Cocaine Anonymous is the fastest growing 12-step program in the country, which attests to its success rate in helping the cocaine addict recover. As such, our Hospitals and Institutions Committee has found the need to produce a Starter Kit for establishing H&I committees throughout the country.

The WSC recently approved on a temporary basis the draft for the Starter Kit. Each kit will contain a statement of purpose for H&I; how to work an H&I program within the 12 Traditions; and explanation of the differences between H&I and regular C.A. meetings; suggested meeting formats; guidelines for structuring an effective H&I committee (sobriety requirements, panel structure as well as voting and election eligibility); and, a code of conduct to which all panelists and officers must adhere.

The H&I Starter Packet is a comprehensive piece of workmanship sure to answer most questions pertaining to the formation of an H&I

Committee particularly in areas where C.A. has been newly established.

Susan S., Chairperson of the H&I Committee, says that the packet is available for use, although certain portions may change after the Literature Committee has adjusted the qualifications portion of the packet in order to make it more consistent throughout the various regions. "The finalized packet will be brought up for approval at the 1990 World Service Conference," she states.

In The Trenches

y most standards, the Conference Committee deals with relatively unglamorous issues, yet its work is crucial for the appropriate evolution of Cocaine Anonymous. Most of the motions proposed by the Conference Committee had procedure at their core. For example the motion to use the term "chairperson" instead of "chairman" in order to keep C.A. gender neutral was proposed and passed by the voting members attending the most recent World Service Convention. Other motions that passed included proxy voting, additions to standing rules and so on.

Of particular importance was passage of the Conference Committee's statement of purpose. As accepted by the WSC body, the World Service Conference Committee is responsible for organizing future World Service Conferences. This will include hotel selection and negotiation, preparation of the conference agenda, review of the minutes from each conference session and subsequent distribution of the material, compilation of the dele-

gate packets, and the development of policies and procedures for conducting an effective conference.

What it all comes down to is that the committee did a tremendous amount of tedious work, a labor of love in the trenches of the unsung. Certainly the results of their help will enhance the appropriate functioning of Cocaine Anonymous as a whole.


