Le Premier Congres Internationale

landmark decision at the 1990 World Service Conference has awarded the bid for the 1992 World Service Convention to Montreal, Canada. Cheers and high spirits filled the room as the overwhelming majority vote was announced by WSC Chairperson, Lucy B. This milestone event will mark the first gathering in our history that confirms Cocaine Anonymous as a TRULY international organization.

In honor of the WSC decision, Newsgram requested the following interview with Roberto V., the colorful and passionate Quebecois who represents the Canadian fellowship in World Service. It was his sparkling presentation and dogged determination which won the confidence of the WSC delegation.

NG: How did C.A. in Canada come into being - how was it born?

RV: Two or three Canadian Narcotics Anonymous members had gone to L.A. for a visit and heard about Cocaine Anonymous. Needless to say, it was just what they were looking for. They brought it back and held their first C.A. meeting in August, 1986 in Montreal.

NG: In terms of numbers, how large is the C.A. Universe in Canada today?

RV: Total numbers - just over 100 meetings in Canada: 80 in Montreal, of which only 16 are English speaking meetings, 15 in Ottawa and 8 in Toronto and Vancouver.

NG: What about the rate of growth do you experience a strong need to extend the program?

RV: Membership has doubled in the last year. We have one new meeting in Quebec which could easily grow to over 100 in the next year.

**NG:** What is the general timbre of C.A. in Canada - what are your meetings like?

RV: We have a few meetings that are quiet and reserved, usually the Rehab Center meetings. But the rest are CRAZY - our people are FULL OF

ENERGY! Why? First, that's just the way we are. Secondly, we believe that the essence of the Program is within the STEPS; that the meetings are merely support. We don't take ourselves seriously, but we take the Program seriously. We have the regular speaker, participation and stepstudy meetings like you do, but we also have "couples meetings" on Saturday and Sunday nights. The couples, usually one addict and one co-anon, need an alternate place to go on weekends and this is one of our answers to that problem. We

have 2 speakers, 2 leaders, (one couple each), and the content is usually geared to pertinent issues within those relationships. From Thursday through Sunday we have 3 or 4 "bars sobre" (sober bars), where people get together and dance, share, party and have fun without drugs or alcohol. We have bilingual meetings and 4 co-anon meetings in our area. Montreal area also gives out free chips, literature and starter kits to new meetings. We do everything we can to support C.A. in our country. AND WE REALLY ENJOY **OURSELVES DOING IT!!** 

NG: Tell us about the format of the French-speaking meetings.

RV: After the Traditions and Steps are read, we have what we call a "12-step rap": A designated person gets up and gives a "rap" to the newcomers, explaining what happens at the meeting and what to expect. He welcomes them and tries to make them feel comfortable. We have about 5-10 newcomers at every meeting, and we want them to know what's going on. I want you to understand, we are a very warm, demonstrative people, the French Canadians. Very expressive. So, then we go on to the GSR report. Then we have the speaker, the 7th tradition, chips and birthdays. We have a different person who gives out the newcomer chips, and that commitment changes every month in order to get people involved. Then we have participation.

**NG:** What about the French-speaking population? You now have French chips and literature, *n'est-ce pas?* Has this had a profound effect on the fellowship?

RV: The Big Book and the 12&12 were translated from the very beginning. It was a necessary task

NG: Tell me about your plans for conventions and other C.A. "support activities".

RV: Naturally, the biggest event is our bid for the 1992 World Service Convention. That will be an enormously exciting experience for us. As for our local events: About every two months, we have picnics, dances, snowball parties, white-water rafting, "spaghetti day" (kind of like Thanksgiving), and something we call Cabane Sucre, or "sugaring-off" parties. This is where we have a meeting and a dance which includes a meal in celebration of the maplesugar harvest. In addition to the regular food, we serve lots of dishes which contain the maple sugar and the "piece de resistance" is an unbelievable dessert made from maple sugar. We are continually looking to do more and more events for the entire family.

**NG**: Do you interact with or have the support of other 12 step programs in the U.S. or Canada?

RV: The others helped us out a bit in the beginning, but the C.A. World Service Office has been our strongest support and connection to the fellowship which we hold close to our hearts.

NG: Is there much interaction between the members of C.A. Canada and C.A., USA - have you exchanged speakers or participated in events?

RV: We MUST work closely with World Service of C.A. Everything that is done in Montreal is done with the full approval of the CAWSO. We also continue to seek further guidance for structure and the betterment of service to Cocaine Anonymous and its participants. As far as the exchange of speakers, we haven't had the honor of this experience yet. We certainly look forward to more interaction with individual members who can share their experience, strength and hope with us.

**NG**: What do you see as the the future of C.A. in Canada?

RV: The fellowship is growing at such an enormous rate that it's almost perplexing. The need for C.A. is widespread. We wish to carry it from shore to shore. Everyone in Canada wants to be helpful: Our main purpose is to be of service. And the 1992 WSC Convention will be an event to be remembered. We are already working hard to organize the most exciting and unusual convention possible. We are hoping to get permission to hold it around the first of July in order to coincide with our Canadian Independence Day celebrations. The Canadian fellowship is extremely grateful and excited for this event.

To make a long story short, we finally met up at home group and found that her answering machine is broken. Within three days, she fixed it and actually called me! (I'm from the school of sobriety that teaches me to initiate the call to my sponsor and not the other way around!) What a delight to know that I am loved and that someone is "here for me" again.

I'm sharing this story for a reason: I think this happens often when dealing with World Services in general, and also within the committees between World Service conferences. By the time the story reaches the last person, the original reality is so distorted it's funny - hardly recognizable. When it comes to C.A., there's nothing funny about losing the original message. Listening is the "art of the 90's", so they say. I personally

have worked on this one, and it's not easy – but it's simple.

Let's reach out, communicate and listen to what each other is saying. All of our groups have a lot of experience, strength, and hope to share with one another. World Services is HERE to serve those groups. Let it happen, in God's time. We've come a very long way in a very short time. Thank you, God! The Conference is an excellent forum for this type of exchange, but I see it even at Area Service Meetings between committees. If we spend more time loving one another and listening to one another, there will be less time for telephone tag.

#### Pearls of Wisdom

Protecting the Fellowship with Liability Insurance

growing and growing, (at last count, our worldwide growth rate was almost one new meeting every day), it seems appropriate that we also grow in ways to better

serve and protect the members, groups and fellowship overall. One of the ways to do this is to make sure our different activities are covered by adequate liability insurance. With liability insurance, the group can be assured of being protected should something happen during an event which might lead to a lawsuit.

In the early days of Cocaine Anonymous, our name alone caused us great problems in getting anyone in the insurance industry to even talk to us. Now more and more of our members are finding insurance agents/companies who are willing to write us insurance protection.

The World Service Board of Trustees urges all fellowships to obtain insurance for their various activities (e.g. dances, conventions, and any other service or fun/fundraising activities).

While some of the fellowships have found insurance to be far more reasonable if they "band together" (several areas join together & purchase the same policy), you should consider that by doing this, it may cause all the of the groups to be held legally responsible for the acts of one specific group.

If you do not currently hold liability insurance, consider this at your next service meeting. If you have any questions regarding this, ask your regional Trustee for details.
