

Cocaine Anonymous – A Fellowship And A Business

Is your Group, District or Area operating within federal, State and/or local guidelines? Or are they selling chips and literature out of the trunks of cars, in a rented building where the service committee meetings are held, or at the office where C.A. has its hot lines? Do they have a seller's permit? A business license? Is a State sales tax return being filed? A federal return? Does the group have a tax identification number? Does your Group accept donations and give receipts for those donations without possession of "Non Profit" Corporation status? Are members deducting those donations on their personal income tax returns? Are accurate records being kept and maintained? These are some difficult questions to ponder. Some of us are unaware of the necessity to operate within federal and State regulations when we are, in actuality, running a business.

Operating in a legitimate manner can be quite cumbersome. A Non-Profit corporation must file federal, State and local tax returns quarterly and/or yearly. In most states, individuals or groups are not allowed to sell anything without a seller's permit, especially if the items are marked up in price. Most groups are not allowed to conduct business without a business license. This would include selling merchandise, and holding events or fund raisers. In addition, donations are not legally tax deductible unless they are going to a registered "not for profit" corporation.

One Area had a problem recently with their tax filings. Their CPA firm failed to deliver the required returns. As a result, they temporarily lost their seller's permit, penalties and interest were assessed, and the Area is still recuperating. They did learn a few valuable lessons. One was to pull

resources from within their fellowship. As many of our predecessors show us how to work the steps, former members of our service structure can also help teach us the way. Furthermore, learning lessons from others' unfortunate mishaps can avoid us the costly and aggravating positions that some have found themselves in. The area also learned that it was imperative that they pull together, unity was a key element here. There was no blame. Only learning from their mistakes. Another lesson was to many of the persons charged with commitments at the Area level. They learned how important it is to follow up, and be responsible in their commitment. They learned how the fellowship can be affected if someone doesn't follow through. Not just individually, but collectively. They all took responsibility and are taking measures to ensure the situation won't happen again.

Having service commitments at the Area level can require responsibilities that many of us are not used to. Although this area was paying an outside accountant to file their taxes, all was not well. It was ultimately the Board of Directors' responsibility for overseeing the goings on of the corporation. It is ultimately the responsibility of all of us to ensure that our service structure is following federal, State, county and local laws. There are resources within our fellowship to draw from. Sober members in their "real life" can be lawyers, accountants, business professionals, ad infinitum. This may be a way they can be of service to give back to C.A. what was so freely given to them.

Many districts or areas are not in a position to operate this way. It can

Against My Own Will I Fell In Love With H&I

My experience with Cocaine Anonymous' H & I service work started much the same as many of recovery commitments; against my own will! The benefits I've received have been much the same as well, a sense of purpose and freedom far beyond anything I could have ever done myself.

About two years ago, I went with my sponsor to speak at an H&I meeting. Until this point, I had avoided service work throughout my four years of sobriety. Since this man had recently become my sponsor, the last thing I wanted was to say "no." I thought I might look bad, especially since I considered him to a "CA fanatic".

Following that meeting, my sponsor and I were talking with the meeting chairperson. He expressed a need for a co-chair at another H&I meeting he was involved with. My sponsor felt I should get involved in service work. He said if I didn't, I could kiss my sobriety goodbye. He asked me if I would help the chairperson with this H&I meeting. Before I could think of a good reason not to, my sponsor had cleverly talked me into becoming the new co-chair. By the way, this meeting required me to drive fifty miles round trip once a week.

The meeting took place in a men's live in treatment facility/halfway house. The residents were predominately straight from jails, on probation, or had narrowly escaped incarceration. To me, these were some scary looking men. I had prided myself on not hanging around this type, now that I was sober. After all, I got sober to "get on with my life," not return to the scene of the crime!

One of the first thoughts that came to mind at that meeting was "what do I have to share with these people? I haven't done the things they have done or come from the same neighborhoods that they did." Of course, I realized, this was just another way I found the differences instead of the similarities.

After sharing my experience, strength and hope with them that night, I was amazed at the positive comments and questions that were sent my way. This was the first real commitment I had taken in sobriety, not only was I liking it, but I found I had so much in common with the very people whom I had judged so harshly.

In addition to chairing the meeting, I was required to attend the monthly H&I business meeting. This meeting allows all chairpersons from the H&I meetings in the District to discuss everything from finances to meeting attendance as well as making sure the meetings were being properly covered by CA representatives. I began to notice it was becoming customary in most open CA meetings to pass the H&I can during the seventh tradition to raise money for chips, literature and books for H&I. The finances for these items as well as the annual H&I day were discussed every month.

I had heard a saying that ten percent of the people do ninety percent of the work. Well, here they were. A group of people dedicated to carrying CA's message to those addicts who were not able to get to meetings. These were the same people I saw regularly at outside meetings, taking commitments and most importantly putting together long term, quality sobriety. Even though these people were what I considered the CA fanatics, I soon wanted what they had.

I found myself taking on a second H&I commitment. Although the meeting was small and often scarcely attended, I found that by keeping the commitment I felt a further sense of belonging and service in the CA community. Most importantly, this meeting brought back memories of my three trips to treatment before finally staying sober.

I've found it is helpful, not only to myself, but to others, to keep rotating commitments after maintaining them for a while. So, I traded in these two commitments for a new one. This one involved taking CA into the jail system. Here again there are differences between me and the inmates, most notably the fact that I didn't go to jail during my using days. However, the joy of being able to leave the facility when the meeting is over is one of the many highlights of chairing the meeting.

I owe a lot to CA, especially to H&I. I encourage everyone with 90 days or more of sobriety to get involved in the magical area of service work. The electric glow you'll get on the way home from the meeting is well worth the time, effort and miles driven to carry CA's message.

be quite costly. If the district or area has a goal, and works each year to reach that goal, it will save potential bankruptcy trying to do it too quickly. Ideally, outside firms can be employed. However, they are often too costly for the small group or area. Usually, it is best for the area to start small and build from there. If you need more information, the World Service Office offers a sample Incorporation Kit for the State of California. This can be used as a template for obtaining non profit status. Contact your local government offices, the Internal Revenue Service, and/or a member of the Fellowship who may be an accountant or lawyer, and find out how you can incorporate. If you are operating in a district structure, the Area as a whole can apply for the licenses, and the districts can operate within them. It is important to communicate on this issue with other groups, districts and the area structure set up in your local fellowship.

As we learn from our mistakes, we can share them with others. That is *experience*. As we grow and prosper, we can support others in their endeavor to succeed. This is sharing our *strength*. As we travel this road together, we can offer faith to those who come in after us. This is our *hope*. Removing egos and personalities, and relying on the Principles of this program, is not always easy. We often forget. To remain prosperous, we must work together in unity, asking for help when we need it, to establish what is best for our fellowship.

The following is the amended (8/95) statement of purpose for the Cocaine Anonymous World Service Unity Committee:

"To enhance our communication and outreach among the diverse elements within the fellowship in the interest of carrying the C.A. message and to promote C.A. Unity"

This committee grew out of a meeting of the "Minority Caucus" at the 1991 World Service Conference (WSC) and the near unanimous sentiment of the Delegates that concerns of racial, ethnic, cultural, physical/mental status, gender, sexual orientation and like divisions and actual or perceived biases within the Fellowship are harmful to C.A. as a whole. The first Tradition tells us that our personal recovery depends upon C.A. unity. Tradition Three reminds us that C.A. exists for all who desire to stop using cocaine and all other mind altering substances, not just some elite factions.

From its inception the committee has been active, beginning in September 1991, meeting nearly every other month, sometimes with few active participants. We have since amended our meeting schedule to twice per year, during the WSC and at the World Service convention. This scheduling allows for more active participation at less cost to the fellowship. It is our goal to utilize mail and phone communications. We welcome all fellowship members to participate as we meet the challenges of promoting Unity, Love and Tolerance within our C.A. family.



activities come from Fellowship contributions via the 7th Tradition, CATW and the CAWS annual convention.


CAWSO used these funds for the day to day operation of the office, to acquire new equipment and additional



Sales of the Storybook are steady and regularly meet projections. Disappointing is the year to year drop in Dance Around the World/Celebrate Around the World from its high point also in 1992. A good showing from the CAWS '95 Convention in Salt Lake City added to the total revenue and the pie chart shows the importance of the Convention to the function of the CAWSO.
