# Coping With Illness In Recovery

The disease of addiction can be full of ups and downs. By the time jobs, money, loved ones, and self esteem have been lost, most of us are pretty beaten up. Life in recovery can be stressful, especially if an addict has no foundation, friends, support or program. In recovery, many of us are finding more to deal with than drug addiction. It is true that if we stay clean and sober, we believe all aspects of our lives can and usually do get better. However, there are those who learn that they or their loved ones are diagnosed with other illnesses, whether a result of their addiction or not. We want them to know they are welcome in Cocaine Anonymous.

We remind you that a Cocaine Anonymous meeting is not just a place to talk about "cocaine and all other mind altering substances." A meeting is for you to discuss your recovery. When a physical or emotional illness, or diagnosis, even a symptom, begins to affect your sobriety and recovery, it is important to know you can share your thoughts and feelings here. We care about you. When someone you love becomes emotionally distraught, or physically ill, you have others to lean on and a place to share your fears in Cocaine Anonymous.

If you have been diagnosed with a physical or emotional illness, you need to know you can feel safe in Cocaine Anonymous. Most of us know someone, a friend, sponsor, sponsee or relative, who has a serious chronic, or even terminal illness. We find ourselves wondering, "How do I work my program with him so sick?"; "What will I do to stay clean if she dies?"; "When will all this sadness and stress go away?". Those of us who have had this experience know that the program teaches us to regard these fellow addicts with un-

derstanding and respect. "The only requirement for membership is a desire to stop using . . .," goes a long way when we attempt to make new members feel welcome in our fellowship. In fact, besides coping with addiction as a disease, many of us have had to work very hard to stay clean and sober after learning we too have an additional illness. We find that addiction is no longer the only disease we have to cope with "one day at a time." Besides Cocaine Anonymous, we realize there will be new support groups to join, different sets of meetings to attend. We see life becoming more complicated.

When faced with a chronic or terminal illness, it is possible to develop and maintain a program of recovery designed for living "one day at a time." Chronic physical or emotional illness can affect anyone. Compassion, empathy and love are often the best help in attaining the spiritual healing we all need. Coping with illness in recovery means working the Twelve Steps of Cocaine Anonymous and "practicing these principles in all our affairs." It means sharing with others when we hurt. It means acknowledging that seeking a Higher Power can help relieve the stress that is such a large part of many illnesses; stress can hold us back and prevent us from keeping a conscious contact with our Higher Power. Stress can cause someone teetering on the brink of a relapse to think about going right over the edge. Stress can make a big difference in how somebody feels about his or her life. We can choose to allow negative feelings and stress to bring us down, or view the situation as a call for our own spiritual growth.

In Cocaine Anonymous we use the Twelve Steps of Recovery because we know they work. However, sometimes

We were in trouble with our addiction, for beginners, but we had more troubles than that. We had cocaine troubles. We had run out. We had money troubles, feeling troubles, loving and trusting troubles, emotional troubles, sexual troubles, marital and relationship troubles, family troubles, health troubles and staying sober troubles. So you see, we had troubles.

What is clear to us about trouble is that we want out of it immediately, It's a human instinct. It's an animal and rodent instinct too. The rat who gets slapped behind the neck by a rat trap doesn't want the cheese anymore. He wants out of the trap. We will do anything to get out of trouble. The question is... what are we willing to do to stay out of trouble? If we get out of one of our troubles, what do we do with the rest?

Cocaine Anonymous taught us, through its steps, how to work through our troubles and learn how to live. We've got what we've gotten because of the work we've done in Cocaine Anonymous. Because of this work, we have something to pass on gently. Sponsorship and sober friendships are holy in this fellowship. We must all find our own serenity and peace in this fellowship of people trying to be better people. Through the steps of this fellowship, we practice these princi-

# I Love the Smell Of H&I in the Morning

ne thing I know for sure is that Hospitals & Institutions have a very distinct smell. I can't help but think every time I walk into my H&I commitment locale that I have walked into a time warp.

First, I should explain about myself. I am the kind of addict that had to go to treatment once for his fiancee, once for his boss, once for his business partners, a few times for himself, once for my wife, once for my son, and a few more times just for the fun of it.

I never really thought that as much time as I spend in treatment facilities, I would ever voluntarily go back without the promise of detoxing, or the threat of overdosing. I also never thought that my 15 trips to various sordid institutions could possibly help anyone. Somehow my Higher Power has delivered me to the place that I needed to be to best serve Him.

In fact, the most rewarding thing that could have happened to me besides my getting sober, was getting this commitment. When I go back to my H&I meeting each week, I see the same thing over and over...

Me

I watch the faces to see how I looked, the bodies to see how I felt, and the eyes to see my fear. I see the despair, the hopelessness and the shame. I smell the sweat, urine and vomit. My H&I commitment helps me to stay grateful, to stay teachable, to be of service and to do God's handiwork. I know that if I ever forget where I came from, I will be right back where I started; if not dead – in treatment for the 16th time.

Dear C.A.;

First, I would like to thank you for the work you are doing. I am trying to recover one day at a time and believe me, it's hard. I've been trying to get active in the program. I have a sponsor, and have done an inventory. But, sometimes the obsession comes back. I pray and am seeking a Higher Power that I call God. It's nice to know that I can open your newsletter and see myself.

I am writing because of my obsession to use. My pride won't let me tell my sponsor. I don't want to go back to that lifestyle again. Before I found C.A., I didn't have any hope. I didn't have anything. I have family problems, relationship problems, and I was smoking all the money up. It took me a long time to get to the point to say I needed help. But I need help. I am sitting in our meeting hall writing this letter. I have \$15.00 and the desire not to use. Believe it or not, you helped. I can't do this alone. I tried, but it didn't work. My pride always fools me.

God has given me two months sober. Most of all, he has given me today, and some good people like you. Don't give up the faith. There are people who need you just to listen. If no one told you today, let me be the first. I love you. May God be with you.

physical pain or emotional weakness, or even the hint of a serious life-threatening illness can tip the scales in favor of our addiction. Come to Cocaine Anonymous and share with other recovering people. Let someone know how you feel. Talk with someone about every aspect of your recovery, including physical and emotional symptoms and illnesses. Step One says we were "powerless over cocaine and all other mind altering substances." Many recovering addicts have concerns about prescribed medication for the stress, pain or symptoms of an illness. We suggest you discuss this with your doctor and your sponsor. Your concerns are important, necessary and well founded. We continue to recommend the steps as a road to recovery from addiction.

We hope you know Cocaine Anonymous is here for you, whether you are coping with chronic illness or not. We are a fellowship of men and women who have lived as many of you have and we understand that your needs are valid. Share these needs with us; we will be here for you.

# The C.A. Logo - Our Legacy

It was March of 1987. The third annual Cocaine Anonymous World Service Convention. A motion was presented by a Delegate from New Mexico to the Conference floor. That motion was to accept an official Cocaine Anonymous Trademark/Logo developed by the Los Angeles Fellowship. The motion passed by an overwhelming majority. The group conscience had spoken.

Shortly after that, the World Service Office produced medallions, or "metal

chips" using the new logo.

In April of 1990, the logo was registered in Washington, D.C. with the United States Patent and Trademark Office. By registering, no other individual or

organization may use the logo.

The intention of the CA fellowship, communicated through that group conscience, was to use the logo on all C.A. literature and publications. In doing so, the logo is kept consistent throughout the C.A. fellowship. There have been instances where the approved logo was not used. In our World service manual, it is stated that permission to use the logo is granted only to a C.A. Group, for purposes of organizing and operating a regularly scheduled C.A. meeting, or by a Cocaine Anonymous District, Area or Region. If a group wishes to use the logo for purposes other than the direct function of their meetings, they must obtain permission of their Area/District Service Committee.

When using the logo, it is important to note that only the official logo should be used. The Conference has not approved the use of variations of the logo. Many have been seen

on printed materials, and memorabilia.

Our logo, like our Twelve Steps, should only be changed by group conscience of the Conference. Remember, it is our legacy. It belongs to the Fellowship as a whole. It belongs to the groups. It is protected by the World Service Office, as commissioned by the World Service Conference.

When an Area, District or Group wishes to use the logo, they should contact the WSO and obtain, free of charge, the approved logo. In that way, we as a fellowship will be following our first and fourth traditions in keeping our fellowship spirituality unified.

# Tradition One – Unity

In recovery, it took some time for me to understand why the need for unity was so great in our fellowship. While listening to "How It Works," I heard the word "we" at the beginning of the first step. I had never heard it quite like this. It became clear to me why we must unify. As a person who traditionally thinks from the perspective of "me," both consciously and unconsciously, it has been a challenge to think in terms of "We" when relating to "Our Common Welfare."

**Tradition One:** Our common welfare should come first; personal recovery depends on C.A. unity.

In Step One our *individual* problem is set out. In Tradition One, we find our *collective* problem explained. There are many places in the Big Book and Twelve and Twelve where self-thinking and selfishness is identified as the problem in our personal recovery. Therefore, it's no surprise to see that our collective problem is the same, and that disunity is a symptom of that problem.

While listening to a tape a few years back, I realized that I ought to seek out where my ego could be invested in each tradition. The result of this discovery was that each time I did this, I began to live in the solution of the tradition, instead of the problem. In the first tradition, as long as the focus remains on "me," I'll miss the "we." I will not know unity. Subsequently, I will miss one of the three legacies in my recovery. I would be incomplete in my personal recovery and in danger. After all, it was in Cocaine Anonymous that I discovered what we can't do alone, we can do together. Tradition One's closing in the Twelve and Twelve, sums it up best. It states, "Thus has it been with C.A. By faith and by works we have been able to build upon the lessons of an incredible experience. They live today in the Twelve Traditions of Cocaine Anonymous, which—God willing—shall sus-

tain us in unity for so long as He may need us."

Tradition Two - Leadership

Step Two. Similarly in the Traditions, the solution begins with Tradition Two. While I am sure there will be those with different views, I am equally sure that what I share is from my experience. It is my sincere desire that the results will be passed on, as we do in C.A. It is my *Hope*, *Faith and Courage*.

Tradition Two: For our group purpose, there is but one ultimate authority - a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern.

There is a great deal to digest and put into practice in Tradition Two. It points out that it is for our group purpose. Our objective is to preserve unity so that we all maintain our individual recovery from a "seemingly hopeless state of mind and body." Therefore, we have only one ultimate authority - "A loving God as He may express Himself in our group conscience." We find points to consider:

- The Tradition states "He may express Himself." I have found that we must be aware of the council of fear and resentment in our conscience. I have experienced them first hand at all levels of service, both as a witness, and as a participant.
- 2. "Our group conscience." This activity at all levels, can be one of the most intimidating for our individual members. First, in laymen's terms, we are talking about constructive confrontation of the principles. I had virtually no experience at disagreeing without being disagreeable. Therefore, fear was most often my founda-

tion in these meetings. I felt that my opinion didn't matter and later, that my participation was all that mattered. By continuing to participate in group consciences' at various levels of service, I find that everyone's input is important. It's important to ensure that the group conscience is informed so all sides of an issue may be considered. It is through this process that God can and will express Himself, and subsequently, unity is preserved.

Once our conscience is reached, we find that "our leaders are but trusted servants; they do not govern." No matter the level, our trusted servants are those people in whom we place our faith to do our chores, to ensure that our conscience is followed. This is where our leaders are asked with love and out of love to help fulfill the direction the group conscience has chosen. Often this process is viewed as political, authoritative and abusive. If this is the case at your group, district, committee or area level, then you may want to look at your group conscience and your trusted servants. Again, our leaders are meant to aid us in fulfilling out the group conscience, no matter what level of service they are at.

In summary, we find that our first solution toward maintaining unity is to seek direction of God through balanced, informed exchange. Upon receiving this direction, we ask our trusted servants to see to it that we follow the group conscience. It is here that I have experienced the principle of Hope in the recognition that no personality is in charge.

While living under the influence of Cocaine and other mind and mood altering substances, my sense of reasoning became a life of hopeless desires. My purpose and aim in life were set on destruction of self and whoever else I could drag along.

Life had no meaning before I began to realize that we all have a place in the society we share with all of God's creatures. Coming into Cocaine Anonymous was the relief my mind, soul and body had been seeking throughout its existence. This fellowship had taught me how to first like myself in hopes that someday I will learn to love and forgive myself. It constantly reminds me that my tolerance of others

begins with my tolerance of self.

To be at peace, brings the freedom of not having to decide where I belong. Just knowing that I belong is sufficient today for me and my Higher Power. For it is by God's grace and mercy that I have been saved from death, institutions, and prison. Because I have been saved, I don't have the right to allow any type of prejudice envy or insecurity to prohibit me from carrying the message to those who still suffer. It's more important to help save someone's life that to allow self perception to destroy both our lives.

If the forefathers of the fellowship did not seek the counsel of a Higher Power to inspire the steps and traditions where would this fellowship be? With peace comes spirituality and it is the spirituality of the 12 Steps and 12 Traditions that governs my life. We all are bonded by the stripes we bear from

our active addiction.
