## **Clubhouses and Cocaine Anonymous**

All over the country (and in other countries now), Cocaine Anonymous meetings are held in a variety of places. Some meetings are held in community rooms at local parks, some are held in meeting rooms at churches, or in hospital cafeterias. Sometimes meetings are held at clubhouses that exist specifically to provide meeting space for Twelve Step groups, and to provide clean and sober people with a place to interact socially. At last year's CA World Service Conference, several referrals from the floor requested guidance and clarification about how CA members and groups can be involved with such clubhouses without violating our Twelve Traditions. The World Service Board of Trustees has discussed the issue at length, and this article is an attempt to explain our understanding of the proper relationship between CA members and any such clubhouse.

Let's start by clearly stating that the CA group is Cocaine Anonymous. The group has been and remains the most effective vehicle for carrying out our primary purpose - "to carry the message of recovery to the still-suffering addict." It is in the group that we recover through working the 12 Steps, learn to coexist in unity by applying the 12 Traditions, and continue to grow spiritually through service employing the 12 Concepts. CA members the globe over protect the group as it is the very core of our recovery today, the place where we get sober and grow together, ever more clear-sighted of Tradition One: "Our common welfare should come first; personal recovery depends upon CA unity."

The group is the CA foundation, not only to its members, but to the outside community as well. So any other service entity that is created through a need to serve the CA group should handle its affairs in such a way (with respect to CA's 12 Traditions) as to enhance the effectiveness of the group to carry its message, further allowing each member the opportunity for service that

may come from any group activity.

It is certainly understood that some CA members will have a desire to participate in activities outside the CA group, such as clubhouses. While there will be those of us that find the CA group sufficient to meet our needs, other members have a desire to extend their fellowship beyond group meetings; some in fact seek a CA social life. We think it wise for those CA members that choose to participate in those outside activities take extra care to respect the integrity of the CA group, ever mindful of the fact that affiliation, whether real or implied, misleads the public, confuses the newcomer, and violates CA's 12 Traditions. What this means is that a CA member who might be involved in any way with the operation of a clubhouse should take every opportunity to remind himself and everyone else that he is doing so as an individual, not as a representative of Cocaine Anonymous.

With all that being said, let it be clearly stated that Cocaine Anonymous does not have clubhouses, although members of CA are free to engage in whatever outside activity they choose. In accordance with our Preamble, "CA is not allied with any sect, denomination, politics, organization or institution; neither endorses nor opposes any causes". Nonetheless when outside activity is engaged in which can easily be mistaken as CA affiliated, such as clubhouses run by CA members, caution must be advised. Remember that not only the public, but more importantly, CA newcomers may get the misconception that these clubhouses are in fact owned or operated by CA. Consequently, outside activities such as clubhouses should be designed for those individual members who wish to participate, while the CA group

## Carrying the Message from Internet to Interaction

I attended the Cocaine Anonymous World Service (CAWS) Convention in Milwaukee this past Memorial Day Weekend. I want to share with you some of my reactions and thoughts about my experience. I have been to many, many conventions during my years of sobriety, but there was something more than special about this convention in Milwaukee.

For the past year or so, I have been involved in an online, not face to face, slow-moving, cross-talking, sometimes smoking, sometimes non-smoking, non-chatroom, share-your-feelings group of Cocaine Anonymous. For those of you who have not yet become computer literate, what this means is that perhaps two hundred of us subscribe to the "Hope, Faith, & Courage" (HFC) meeting of Cocaine Anonymous. As a result, each of us receives a daily dose of recovery, chat,

opinions, stepwork, sharing, and other comments and contributions from anyone else who is subscribed. This can mean dozens of pieces of electronic mail a day, but to me, it's like being an active member of a very large CA group. I began as a lurker, as I usually do in regular meetings, sitting in the back, observing, waiting to be lured into participation. I didn't share much, waiting to see how the interaction went and wondering if I'd fit in. I noted the key players and paid attention to the process. Eventually, I became part of the group and of the process, first commenting, then responding, and finally voluntarily sharing when the spirit moved me. I came to think of myself as a major part of the meeting. All that changed for the better on Saturday morning at the convention.

Whenever he had seen any of us the day before, or recognized an HFC name on a badge, Kevin had given us all green continued on Page: 4

ribbons and we walked around the hotel proudly wearing them, as no one else had any. Then, the three dozen or so HFC members who attended the CAWS convention all met FACE TO FACE in a meeting room at the convention. This was very incredible. One by one, we all introduced ourselves by our "addict names" followed by our screen names so everyone would recognize each other. It was wonderful how each introduction and recognition encouraged another "oooh" or "ah" or "so that's who that is" or "so that's what you look like"! I was overcome with feelings of sheer excitement and joy that we were all meeting face to face for the first time. At the same time I was elated and amazed that we were actually able to pull it off, and how utterly grand this project and accomplishment actually was! I sat in total awe as I heard each person's story and was finally able to match faces with personalities as I began to recall little things I'd remembered from one post or another along the way. I remember thinking that this was enough, that the convention could end right now and I'd be grateful. I remember hearing sighs and seeing smiles when I shared who I was and I thought, "Now I'm REALLY a part of this group. I feel like I do at my home group. Everyone here is my friend and it feels good."

Suddenly the allotted magic hour was over. The transition had happened. We all knew in an instant that things would never again be the same. Speaking personally, I will no longer be able to imagine what each of them looks like in that "impersonal way." I will no longer be able to share with uncertainty and lack of investment about topics or comments made by "someone who lives in a place far away and who I've never met." However, I will also never again have to wonder if there's a smile or a frown in response to my posts. I will know in an instant how some of them will react to my joys and sorrows, because I spent real, face to face time with them and got to know each one on that "other" level. The wall has been

lowered and we've hugged and shaken hands and smiled and cried over it resulting in a much more personal encounter that will never allow it to go back to being as it was.

Up until just last year, Internet activities in Cocaine Anonymous were a part of the Public Information (PI) Committee. Through the World Service Office Area web sites and other links posted by members and friends of CA, word of CA online and of this meeting spread throughout the cyber community of Cocaine Anonymous. At the CA World Conference in 1998, a standing Conference Committee on the Internet was established to handle the issues raised by this new medium. It is difficult to say how many sick and suffering addicts will have the opportunity to tune in to this new avenue of recovery, but it is certain that thousands today who have found us online have an awareness and a hope of a better life they did not have before.

I feel emotional in retrospect, as I often do following conventions. I like to think I go to them intending to bring something, learn something, and take something away. At CAWS in Milwaukee I did all three. I brought with me my experience, strength, and hope. I brought humor and joy and my outstretched arms to hug in person all the mystery faces I'd only imagined. I learned how important this contact is, whether it's online or in person. And I'm still processing just what it is I took away. I know my life has been touched by the friendship and compassion I feel from the new friends I have and that I'm grateful beyond measure for the opportunity I received to even go to this convention.

I knew a few of them before this convention and I feel I know them even better now. I feel closer to those I met for the first time face to face, and I shall look forward to getting to know those members who will join this meeting as a result of learning about it at the convention and from reading this story. We already plan another face-to-face meeting of the HFC group at the CAWS Convention 2000 next year in Phoenix and I hope to see everyone there.

## **Faith**

A short time later when a person with years of recovery stopped by my place I asked him, if I can't see Faith and don't understand Faith, how could it ever work for me? He told me to take some food from the freezer and put it in the microwave. Then he said, "Do you believe the microwave will heat your food?" I said, of course it would: All I have to do is press the right buttons, wait a little while and it will be heated. So I pressed start and he said, "Look through the glass and tell me what you see." I saw nothing but my food going around and around. So he asked me how the microwaves in the oven heat the food. I thought for a minute and then confessed I really didn't know.

So he said, "You Believe the microwaves will heat your food. You can't see the microwaves, and you don't understand how they work, but you can still get the benefit of a cooked meal. I learned that day that if I Believe, and take the corresponding action, that I don't have to understand Faith to get the benefits of Faith.

I have Faith in the program of Cocaine Anonymous because I Believe the program works, and I take the Corresponding Action by working the program every day to the best of my ability. I have Faith in the God of my understanding because I Believe in Him, and I take the Corresponding Action by turning my will and my life over to His care every day.

## What's a Relapse?

Relapse - Latin - to fall or slide back; re - back; labi - to slide

- 1. "to slip or slide back to return"
- 2. "to slip or fall back into a former condition especially after improvement or seeming improvement.

Specifically (a) to fall back into illness after recovery or seeming recovery, (b) to fall back into bad habits, wrongdoing, error, etc.; to backslide."

3. "the recurrence of a disease after apparent recovery."

(Webster's New 20<sup>th</sup> Century Dictionary, Unabridged 2<sup>nd</sup> Edition, Copyright 1970)

One day a friend and I were having a thoughtful conversation. Both of us, having substantial sobriety time, were highly opinionated about the meaning of the word "relapse." She shared with me her experience of having gone into a couple of programs for reasons other than to "recover," i.e., drying out, getting some rest, receiving temporary shelter or perhaps just acquiring a meal. She explained that she never considered the "picking up again" a relapse, because she'd never heard anything about the Twelve Steps and never stayed long enough to be relieved of the obsession nor the phenomenon of craving. These brief "breaks" lasted no longer than a day or two which resulted in leaving the program or facility and continuing forth with what addicts do best. I told her I'd never heard her share about this when speaking at meetings, and I've trudged with her for quite a few years. This was a chapter of her story that I'd not known.

She explained that she never shared this because she didn't consider these episodes to be a "relapse." Relapsing, in her opinion, was to relapse *from* something, and she wasn't in the program long enough to even be introduced to the Twelve Steps, much less to hear anything about the disease. My question then was what is to be considered a relapse — a few days, or even a few weeks? Just what makes going back to using a relapse? I looked askance and continued questioning my friend's justification/explanation. Is just the coming into a program enough of a reason to consider going back

to using a relapse? Is it the spirit's way of telling us that we're tired, or at least beginning to become tired? How

many times have we heard it shared that people didn't hear anything in their first, second or even twentieth program or meeting? That the "nudge from the judge" was just because they needed a brief rest, but later they came to stay? Does one have to be introduced to the Twelve Steps of recovery to consider picking up one more time a "relapse?"

Who's to say what the answers are? I was told early on that this is the only disease known to man that has to be self-diagnosed. No one can tell another about that person's truth. Being highly opinionated, I had to back off for these reasons. The question of whether my friend had ever relapsed was not about me and my opinion, and today I do understand how to agree to disagree.

My understanding of what constitutes a relapse was formed early in my recovery. Some old-timers told me that anytime that I stopped — whether it was because I ran out of dope, money, or just needed to rest — and then would resume using, I had relapsed. I used to pride myself on having come into this program once and having stayed. But my truth is that, yes, I had relapsed many times. I could not stay stopped. I no longer brag about never having experienced a relapse.

I wonder what Bill W. would have said? Even he called his feeble attempts at staying stopped "relapse." This was before there was a twelve-step program.

Yes, recovery is about one's own truth. No one can diagnose another's ailment but the individual. Who am I to tell another that their story should include all forms of relapses, whether it was before or after being introduced to the Twelve Steps? That is between each individual and their Higher Power. No matter what avenues we take to get here, the real point is: Do we remain to stay, one day at a time?

should remain unimpeded by the activities of these outside entities.

Clearly stated, the CA group business should in no way be associated or affiliated with any outside entities, including the clubhouses in which its meetings may be held. The Sixth Tradition states, "The CA group ought never endorse, finance, or lend the CA name to any related facility or outside enterprise, lest problems of money, property, and prestige divert us from our primary purpose." The tenant/landlord relationship of the CA group to the clubhouse should not include the co-mingling of funds. Nor is it appropriate that the landlord dictate structural parameters for the CA group. An outside entity deciding operational procedures for a CA group or the group servants' responsibilities would be an example of a serious Tradition violation. Of course, a landlord is free to negotiate rent with any group, or to insist that certain cleanup procedures or other restrictions be respected, but should have no input on how the meeting itself is run.

Remember that the public at large will already see CA members heading up these outside activities and may very well view them as CA clubhouses. Thus, those outside entities that are so led by and aligned with CA members should seriously consider being guided by the 12 Traditions as well, although it is clearly understood that CA has no authority to instruct them to do so.

If, after reading this article you still have questions related to clubhouses or other similar outside entities or operations, I encourage you to contact your Regional Trustee to discuss the matter further, or to send your World Service Delegate to the Conference with your questions or concerns.

## The Belonging

As I grew up and realized I had a stepfather and a half sister I always had the feeling I didn't belong. Later when I was severely mentally and physically abused by my stepfather, I knew I didn't belong. In fact, I ran away from home when I was in the first grade.

As I reached my teens I fell into a crowd that loved to party and experiment. We did everything from sniff lighter fluid to the pass out game. Drinking beer and smoking pot was as natural as skipping school in order to find time to do it.

After years of being sick and tired of being sick and tired I found Cocaine Anonymous. I talked the talk really well during treatment but I still knew I really didn't belong. I needed more field studying. As my field studying came to an end I still didn't think I belonged, but Cocaine Anonymous was my last hope—so I had to belong.

With six years of clean time under my belt I was elected to be a World Service Delegate from my Area. I came to the Conference last year and was told I had to belong to one committee or another, so I chose the H&I committee since after all I did come to CA through a treatment center at a hospital.

Upon returning to my Area I joined the H&I committee on the Area level. I became treasurer and thought I belonged. Seven weeks before the CAWS Conference I was asked if I wanted to take on starting a new meeting at a treatment center. I needed to do more service work so I gladly took on the job. The first five weeks went well and the facility was pleased with the progress of the meetings. The topic of the sixth meeting was Step Two. We finished a little early and I wanted to use the hour to its fullest, so I spoke. I don't know where the words came from or how I managed not to stutter and drift off - but out they came. This incredible warm feeling came over me and I knew it was right. I felt serenity, joy, peace. I felt really useful, and I felt I really BELONGED.
