SHIFT OF PERSPECTIVE

Ever since I can remember, I have avoided feeling and have always have created a false reality for myself, which involved developing skills to avoid any and all emotion. Blame became my best friend as I could avoid responsibility by holding others accountable for every problem in my life. As a child of adoption, I felt that this was an essential skill for being accepted as well as avoiding the truth about myself. Another skill that I developed in order to avoid rejection and being loved was dishonesty. This act throughout the course of my first 28 years came at the cost of being unable to accept what was true and false in my life and deep down in my heart. I also couldn't accept help when I was hurting because it would shatter the perception that I had given others as a result of my dishonesty. I was unable to admit the fact that others could accept and love me, which led me to chronic cocaine addiction and alcoholism.

My ensuing addiction and alcoholism were all means to soothe the inner pain and quiet the voices and feelings of inadequacy in my head. By the time the disease had a grip on me, my friends had already started to walk away after questioning things I had said to them, which made me want to use and drink more. I never knew of the commitment and honesty of real friendship because I only wanted acceptance among my peers, yet I couldn't be honest enough to share the things in my life that were essential to getting to know the real me. Whenever friends would stay no matter what happened or what I said, it scared me more because I never thought that they really wanted to be my friends often seeing glimpses of who I was as a human being. I would catch glimpses of my true self during moments in the mirror, yet was filled with so much guilt and shame that I avoided that person all together which would cause me to use and drink more. The fear of getting to know the

real me caused me to distance myself from my friends, family, goals and eventually reality.

In time, those goals in life that I strived to (college education, jobs, and achieve relationships with family) changed in order to suit the needs of my increasing addiction. I had to consistently adapt to the demanding destruction of everything I had worked to build in my life. I didn't feel worthy to live. When everything I valued disappeared and the mask deteriorated, I had no ego or pride left – although it took a long time to discover that. As a chess master in orchestrating my life and predicting four moves ahead, I now had nowhere else to move or go. Along with everything material, my soul was obliterated and I couldn't compartmentalize my life anymore. I knew that I needed help, and it took a God greater than my own understanding (who I felt had abandoned me long ago) to help me on the journey to rediscover what I had thought I lost. On that journey I found a new family who showed me unconditional love, no matter what I had done or who I was. This journey also taught me how to love others and most importantly how to get to know and love myself in an honest light.

When I stopped playing God, everything changed. I found that the journey presented itself to me in the form of new friendships and a fresh start with my family. It has taken a lot of hard work, perseverance and a willingness to go to any length to make right the wrongs of the past in order to ensure continued sobriety. The feelings that I used to hide by drinking and using no longer makes me feel guilty or shameful but rather hopeful. I have found a new freedom on this journey by understanding my fears and turning them into strengths. The rooms and people of Cocaine Anonymous have given me strength in times of fear with the kind of

I came to C.A. by way of a friend that I met when I was in Rehab. She and her husband invited me to my first C.A. meeting. I had been to A.A. meetings, but didn't find all that I was looking for there. Alcohol was not my primary problem; I also abused prescription pain pills (opiates) and marijuana. I had also tried Narcotic Anonymous, but I didn't feel comfortable there. At C.A. I was approached by friendly, outgoing people who told me to "stay!" They also immediately put me into service. which was working a mini-marathon. I have enjoyed being a C.A. member for at least three years of my four years of sobriety. In my active addiction, I was homeless and desperate. I am also dually diagnosed, so I struggle with mental health issues as well. Today, thanks in large part to my participation in C.A., I am on my way to becoming a productive member of society once again.

The Concepts....The What?

We're a study group... not a structured C.A. group, more a collective of C.A. members who meet every fortnight to study the 12 Concepts together, some of us have been involved in several similar study groups and for others this is the first time. We are all active in C.A. service at different levels within our structure and had a desire to grow in effectiveness and understanding in our endeavors to support our various service committees in carrying the message to the addict who still suffers. Just as we sought guidance from the big book of Alcoholics Anonymous to find a solution to addiction, we then began to consider the content of the book Twelve Steps Traditions and grasped a better Twelve understanding of the Traditions, in order to play our part as unified members of our Fellowship at group level. Feeling oft confused in committee environments, we struggled at times to comprehend how various committees or boards could work and cooperate with each other and how they interacted and realized the will of the groups. Our solution was revealed in the common sense, wisdom, principles and spirit of C.A.'s 12 Concepts of World Service.

Our reference document for this process is, as suggested in the C.A. World Service Manual, The A.A. Service Manual Combined With 12 Concepts for World Service. The benefits of open discussion has brought the subject matter alive for us and allowed us to remain open minded to the interpretations of others.

We've been meeting for over six months now and thought this week we would try and write a collective article on the first three Concepts and submit the article to Newsgram. (If you're reading this...we've actually managed to get published!!)

We thought we would attempt to explain in simple terms the beauty and interplay between the first three concepts and how these can easily be applied at all levels of service. Within the early Concepts authority and trust are clarified and explained. We learned that ultimate authority for our World Services resides in the collective conscience of the groups. In order for a group to effectively interact with other groups and Cocaine

Anonymous as a whole; and to allow the group to concentrate on its primary purpose, it is necessary for the group to delegate authority to a trusted servant as a representative - the Group Service Representative (GSR). The groups representative interacts with other GSR's to conduct business within the district or area that may benefit and support local groups through activities such as literature distribution, helpline, website, Public Information and support of our World Services.

Often the GSR will need to take part in informed discussion and it may be necessary to vote on issues that require immediate attention without consulting their group. One reason for this is that it would not be practical or efficient to do so, another is that the GSR has been 'delegated' the authority and therefore is the trusted servant, as described in Tradition Two. The GSR is trusted to vote according to the dictates of their own conscience. This highlights mutual trust as an essential principle upon which our Fellowships structure and services depend in order to work in harmony and effectiveness.

An additional benefit of our study group is the forming of new friendships, a commitment between us to support, encourage and learn from each other. Its made study fun! Tonight, with much laughter and food, we attempted to write a simple article as a group and we hope you are tempted to find some members in your locality with which to embark on a similar journey into the Concepts and their simplicity.

HOW THE PRINCIPLES OF HOPE, FAITH, AND COURAGE HAVE WORKED IN MY LIFE TODAY

Over 43 years ago when I was a teenager I fell in love with a girl. She was kind, beautiful and innocent. Our parents didn't coach either one of us on birth control. They stressed abstinence. That didn't work, as the forces of nature and hormones were far stronger than words of caution. She got pregnant. Out of fear we kept this secret from our parents as long as possible but eventually she began to show and we had to fess up. Being so young and unprepared for parenthood the decision was made to give this son up for adoption. It was kept secret to protect her reputation. She went to a maternity home, where she received counseling, support, and excellent care. I didn't realize at the time of the decision that this meant the relationship would end.

My recreational use of drugs and alcohol soon became my escape from the guilt, shame and pain of a broken heart. I became very ill with the disease of addiction. My life would never be the same, I could never go back to the way it was. I will spare you the details of the many unhealthy relationships that followed and the years of trying to cope with life with chemicals except to point out that I had another son during this time.

My second son was born with high functioning autism that went undiagnosed. His mother and grandmother were in denial that there was any problem with him. We divorced and I got visitation rights but no say on his healthcare decisions. Scholastically gifted throughout school, but he was socially unable to connect with other people very well. He eventually took his own life at 18 years of age. Again I was heart broken. I was eight years clean and sober in Cocaine Anonymous at the time. Escaping the pain and grief with drugs and alcohol was a temptation but I knew that it wasn't really a viable option and the fact that I would run out or die was very clear to me. I had remarried and had adopted the two sons in that marriage and I couldn't bear the thought of them being abandoned by me. I got into grief counseling, doubled up on my meetings and took on more service work. Eventually I learned to live with the pain and to give it to God.

I began to rely on my Higher Power more than ever before. I got the feeling of *Hope* and focused on being a good father and husband. I coached the boys in Baseball and football. I taught them how to hunt and fish and make a camp. I was there for them.

My Faith continued to grow in knowing that this is God's Universe and if I continue to love and serve others I will be all right no matter what. The service ethic the Fellowship taught to me rubbed off on my two adopted sons. They both strive to help others; one is a fireman and the other a minster. The bond of love we have is very strong. Having the Courage to stick by them even as the marriage to their mother crumbled could only have come from me asking God and my sponsor for help. It takes Courage to ask for help.

At 15 years of sobriety I am single again, half of my net worth gone, self employed, disappointed that life wasn't turning out as I planned. The solution once again was to double up on meetings, focus on steps, get into service work, and get out of self. As a result of following that advice I met a bunch of great people, went all over the world, grew spiritually, and learned about Traditions and Concepts. You taught me so much as I volunteered at World Services for six years.

Along the journey I found renewed *Hope* that I would find the person God intended me to be with. That occurred as a direct result of service work. I asked for the *Courage* to be myself and to be honest and unselfish. She and I have been together living a joyous life for over ten years now and I have a wonderful stepdaughter, mother-in law and brother-in-law, all a result of having the *Faith* that God would provide for us.

So now for a real mind blower - Robert, the son I gave up 43 years ago - found me after doing some hunting on the Internet. We started by emailing back and forth and developed a friendship and trust, very organic without any expectations on each other.

It turns out he was adopted into a loving, caring, nurturing family. He flourished in the environment that I would never have been able to provide him. He went to college and got his Masters degree in History. With that he could be a teacher. His adoptive father was a teacher and he wanted something more than that. He entered law school and graduated at the top of his Class. He clerked

for a US District Judge in Hawaii for a year and then joined a prestigious law firm in San Francisco to pay off his student loans and save some money.

He got the travel bug and decided to "see the world." He went everywhere. He finally settled in Seoul, Korea, he loved the people and the culture there. He learned the language and went to work for a law firm there. He met and fell in love with his wife of five years. They have a 4-year-old daughter named Victoria. A law firm in Vienna Austria recruited him and they moved there two years ago. He has been able to work on some high profile cases, the last of which was concerning getting compensation to a family whose artwork was looted by the Nazis during the Second World War.

They have decided to return to South Korea. They stopped in Oceanside on their way back and spent a few days with us. I can't put into words the feelings I had when I heard his voice for the first time and laid eyes on him. What a gift. I got to play and hold my granddaughter who speaks English, Korean, and German at four years of age! We spent the day at a park, bonding and laughing. Amazed at how similar our traits are over three generations. How much our personalities and temperament is genetic! What a fabulous visit we had. I am on such a great natural high now.

So here is my enlightenment: All the guilt, shame and pain has vanished. We gave a gift of love to the world 43 years ago and it has been returned. We are full of joy and love today with no regrets, just gratitude.

You gave me *Hope* when I came through the doors. You taught me to have *Faith* that this could happen. God gave me the *Courage* to explore this possibility and be willing to be vulnerable and move forward with this.

This all happened when it was suppose to. On God's calendar not mine. Robert lost his adoptive father ten years ago to cancer. It took him this long to be ready. It took me 26 years of recovery before I was ready. We both believe this to be divinely choreographed.

Thank you God. The future is bright. We have Hope, Faith and Courage.



Trustee Corner:

THE SPIRIT OF ROTATION

In an older Fellowship, the old timers relied on rotation to give newcomers jobs. That practice contributes to how we function and work together today. Rotation is a practical, organizational and spiritual principle. It is tied especially to the Ninth Tradition. Let me read how it is noted in the Twelve Steps and Twelve Tradition (Long form, page 191-192). "Each A.A. group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee and the groups of a large metropolitan area their central or intergroup committee, which often employs a full-time secretary. The trustees of the General Service Board are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office at New York. They are authorized by the groups to handle our overall public relations and they guarantee the integrity of our principal newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole they derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness."

The Ninth Tradition states two important ideas. There is a connection that rotation has with the principle of leadership and being a trusted servant (Second Tradition); and, that rotation is vital in our service structure from the local groups to the World Service level. It is vital from the top of the upside down triangle to the bottom.

As many of us have learned from our local areas, it is better to turn jobs over instead of letting one person do it forever. There is also a connection here with the often-cited problems associated with the Bleeding Deacon element.

. In Areas and Districts the two-year rotation is the conventional approach. At the World Service Conference each delegate serves a term of four years. The World Service Conference committee chairpersons' term is two years. The non-paid World Service Office Board is for a period of two years. The WSO Trustee

term shall end at the close of the second successive WSC (two years). No Regional Trustee, Trustee at Large, Non-Addict Trustee, or World Service Trustee shall serve two terms (four years). The WSO Trustee may serve two consecutive two-year terms (2 years + 2 years).

I strongly see that leadership and rotation are important principles entwined in the Ninth Tradition and Ninth Concept throughout our service structure. Leadership and rotation are essential to a well-functioning and responsible service structure from our groups throughout our World Service structure.

Bill W. wrote this about the Ninth Concept in 1962. "With leadership we shall have a continuous problem. Good leadership can be here today and gone tomorrow. Furnishing our service structure with able and willing workers has to be a continuous activity. We must continuously find the right people for our many service tasks."

I've seen and heard the stories about Areas, Districts, and Groups that can't get new blood to fill service positions. This is especially true if we are not leading. "A great leader inspires confidence in other people and moves them to action." It may never be an easy task for groups and areas to find and groom able leadership to step up to the responsibility. A simple and obvious solution would be the best. Rotation of leadership, and service workers works best when there is a sense of continuously grooming alternates to fill in. It calls for sponsorship to play a vital role in this process.

I have several definitions for Spirit of Rotation, but this is one most quintessential The spirit of rotation means more than just giving up the title of a service position. Rotation means truly letting go of the control and the actions. It means allowing new GSRs, Chairmanships, Committee Leaders, and Officers to make mistakes without criticism and do their jobs without undue influence from those who have rotated out of those positions. It means allowing the entire service structure to operate with God leading the way by expressing Himself in our group conscience. The benefits of rotation are very real and practical. The

My name is Kenny, and I am a hopeful, recovering addict. That was not always the case. I was a hopeless dope fiend for many, many years. But, how did I get to "here?" I could say getting busted, the judge being harsh, or just bad luck. In truth, it was very simple. It was God.

I grew up being a very shy, reserved kid. I was introverted, quiet, and a good student. I grew up in "the hood" in the late 60's, early 70's. Most of the time, I felt out of place. I felt that I didn't fit in with the middle class, or lower class kids. But damn, I sure wanted to be a part of something....the brainy kids, the problem students, the athletes. I lost myself by trying to fit in.

I started getting high at thirteen years old. I smoked weed, took seconal (red devils) and drank wine. By the time I reached high school I was using LSD with the hippy "heads." Even though I had grown up with a church background (a religious home) I was not spiritually connected. In college I started hanging out with returning veterans coming home from Viet Nam. On the weekends it was pimps and "ho's." Soon I was snorting heroin. A little while later, I was injecting it. It went down deep! I wasn't "shy" anymore. I wasn't "reserved" anymore. I was cool! Or, so I thought.

Heroin early on told me I had no pain, no issues. It covered up my fears, insecurities, and flaws. It robbed me of just being "me." I never found the "real me."

Through all of this, I experienced many blessings. I had two beautiful sons, a loving and supportive wife, and a rewarding career. I did not appreciate any of these blessings.

So what happened? Five years ago I was spiritually bankrupt. I was having an affair. I was not emotionally available for my kids. I was not giving eight hours of work for eight hours of pay. Because of a death in my family, I started carrying weapons and got arrested. I was ordered to treatment by the judge. A C.A. H&I panel came in to deliver a message of Experience, Strength, and Hope! They told us we could recover and walk in our own brand of dignity! They said that the big book *Alcoholics Anonymous* could lead us to a power greater than ourselves. I am forever grateful to Cocaine

Anonymous and H&I in particular. That was three and a half years ago.



DEALING WITH SICKNESS IN RECOVERY

I recently had an emergency hysterectomy. Bombarded with emotions I sit and try to differentiate between what is normal and what is addiction trying to rear its ugly head. Is all of this normal? Absolutely! Does it feel normal? No. I've learned that I have to rely on what I know – not what I feel.

Being clean for two years had given me distance from addictive behavior because that's what I worked on so hard: to function, to live independently from my addictive behaviors. Sickness threw a wrench in my progress for a minute, but I am able to reflect on what is expected and what needs to be told it can't stay.

I told myself for two years that I was emotionally healed. I never wanted to feel self-pity again. I never wanted to feel like I was unstable again. I didn't think I would. When I did feel those things, my distorted perception told me I failed because of my feelings. That's the furthest thing from the truth. There is a way of thinking for me that is so destructive and so earth shattering and it is called "perishing mentality." I read something once that a perishing mentality is defined as a "woe is me" attitude. It is not a reflection of a thankful heart. Emotional hurts can overwhelm any of us. It also said the perishing mentality develops quickly and is mired in self-pity. Should we shake our fist at God and ask "why?" Or should we ask what He wants to teach us through our trials of life? Do we really want to heal? Do we really want to back track?

Being a woman over 40 in recovery during a prison sentence holds enough challenges of it's own, a major change in your body through sickness adds fear. A real fear. No one wants to die in prison. No one wants to experience all these changes alone, away from loved ones and locked up. Where do I direct my thinking from here? I must turn to what I know and that is this too shall pass: don't get high.

I must think on what my Higher Power has done for me. How far He has brought me and I must remember He's not done with me yet. One of my greatest character defects is taking things to the extreme. Like when I get a headache – I think, "oh my god, I've got a brain tumor." I think it's safe to say most of us addicts are extremists. I've learned to choose between what is real and what is extreme, but it's not easy because addiction wants to remind me how sick I am, not how far I've come. I have to continue with my physical routine such as making my bed, washing my face, and doing my morning meditation and eventually emotions will follow. If I don't continue with the positive physical activity I will go back to destructive ways like sleeping all day, wearing the same clothes, feeling sorry for myself and not pushing through.

I am not going to lie to you. Being in recovery is work, but it is so rewarding. If working hard to evolve keeps me clean one more day...it's worth it!!!

YES, YOU CAN START A C.A. MEETING.....

I remember hearing that all a person needs to start a meeting is a resentment and a coffeepot. Practical experience has shown me that although the coffeepot is usually necessary, the resentment is not. But there is a little more to it than that. For me, it began with a desire to stay clean and sober, to help others, and to carry the message of Cocaine Anonymous into an area that had not seen an active C.A. meeting in over 20 years.

In March of 2010, I decided that I wanted my life to change. After spending over 20 years in active addiction I had finally had enough. At the time I didn't know that C.A. even existed. If someone had told me about it I would have likely said what I have heard countless times from others in my town, "I don't do very much cocaine; I'm a meth-head." But since there were no C.A. meetings here at the time, that didn't happen. My family found an out-of-state treatment center for me in Alabama. It was there that I attended my first C.A. meeting and found freedom in a Fellowship that welcomed me and offered freedom from all of my addictions.

Upon returning home to begin my new life in recovery, I first went online to seek out a C.A. meeting in my town. I did not find one. However, there was a notice on the Florida Area Web site that there was a convention coming up soon. At this point I called up Tim C. (my first sponsor) and asked him what I was supposed to do. I loved C.A. and had found a home for my recovery there, but the closest meeting to where I was staying was 30 minutes away and I had no driver's license at that point. He responded, "Well, maybe you are supposed to start one". That kind of had me stuck, as I was treading unfamiliar ground. But Tim had never led me anywhere but in the right direction. I didn't know exactly what to do, so I turned it over to God to handle. This is how I know it was God at work: Within the week I was contacted by a longtime friend of mine, Mark, who is a church Pastor. He said he was taking over a local church and he wanted a 12 Step meeting there. I was floored. Never in my life had things just fallen into place like this. I told Mark about the Fellowship of Cocaine Anonymous and that I was seeking to start a C.A. meeting, but that I had some more tasks to accomplish before we could get everything going. He told me not to rush, find out what I could and get back to him. I was nine months clean and sober.

At the Area meeting, I was introduced to the trusted servants from the closest district. They ushered me into the Area business meeting, and when it was time for new business to be addressed Adam B. introduced me, saying that I was interested in starting a C.A. meeting where there were currently no meetings being held. Someone asked how long I had been clean and sober. I answered, "nine months." Before leaving that day I was given a starter kit of literature and rack, key-tags, World Service manual, and copies of the readings. I also left with a feeling that I had taken a step into a bigger world. I knew that I belonged.

I next met with Mark to discuss having the meeting at his church. It was in a great location! He took me to a room with outside access and said, "This is your room". He wanted to donate the room free of charge, but I explained the Seventh Tradition of self-support to him. We settled on the amount of \$1.00 per month and the "Hope in the Highlands C.A. Group" had a start.

This was the point where I called Tim C. and said, "Hey brother, there is a new C.A. meeting in my town!"

Tim replied, "Did you start it?" "Yes," I said.

Without missing a beat Tim said, "Great job, be prepared to be there by yourself a lot." Wise words, also true. I set about to put the "Where & When" in conspicuous locations at meeting rooms around town. I got a coffeepot and supplies, and started showing up. I went to A.A. meetings to keep up with my program, always looking forward to Tuesdays and Thursdays and hoping someone would come. The lights were on and the coffee was made. People came, one or two at a time. Soon there were enough of us to become a group. This was in January of 2010.

Three years have passed, and there are currently five C.A. meetings in my town and the surrounding area. One of these is an H&I meeting in the detox unit of the largest county hospital. There are two open meetings at a transitional center. People are getting involved in service, people are staying clean. We are seeing the

people being reached continue to show up, take on service commitments, and help others. I have had the opportunity during this short time to meet some great people, to practice the 12 Steps, and the 12 Traditions. 





"Henry Ford once made the remark to the effect that experience is the thing of supreme value in life. That is true only if one is willing to turn the past to good account. We grow by our willingness to face and rectify errors and convert them into assets. The alcoholic's past thus becomes the principal asset of the family and frequently it is almost the only one!" (Alcoholic's Anonymous, page 124). Remember that our past may be of 'infinite value' to those continuing in their struggles with addiction. A Higher Power, through C.A. has brought about miraculous transformation in the lives of so many. Your story and experience with C.A. recovery are necessary to continue the miracle. A NEW HIGH FROM H & I

H&I IS A BIG PART OF MY RECOVERY

I got hooked on H&I and other service work when I was sentenced to 14 years in prison for some robberies I did. I didn't think I would live to reach 20 years old, but God had other plans for me. I would listen to the men who came into the county jail and prison. These men were from H&I. They were addicts, just like me. Most of the time when I hear a share from one of them I would say "that sounds like me." Some speakers said they had 10, 15 even 20 years of sobriety! At first, this was hard to believe, but I found myself coming back to any H&I meeting they had in the county jail. When I was finally sent to prison, I did the same thing. I was sent to a "recovery program" in my last 18 months of prison. After I was released, ten and a half years later, I went straight into a recovery program located in Berkeley California. I stayed in this program for three years. Today, I'm doing H&I and other service work. My life is great today. By the grace of God I now have 19 years of sobriety. Thanks to H&I and the Twelve Step Recovery Programs.


