HAVING FUN IN EUROPE

Today I know I am an addict. Some may disagree (no problem) because I always took the single same mind-altering substance in liquid form, but I can only tell my own truth and that is: I do not suffer from heroinism, crackism, cocainism, baribturatism, etceteraism, and alcoholism. I suffer from the disease of addiction and I never took a drug of choice (no choosing involved, it was a must), but a drug of circumstance. I lapped it up until it stopped doing the miracles it once had done and then it ate me alive while my soul was dead already.

Thank God I found the Fellowship of Cocaine Anonymous, because I could not have stuck for longevity elsewhere. I found I cannot work this program on my own. I cannot sit on my sofa with The Steps and the book and do it alone and just dip into a pastor's office for visits when I need someone's ear to share inventory. And I cannot work this program in the middle of a half measures- suffice-for-me-easy-does-it fellowship. I need to be surrounded by other addicts who have that deadly earnestness Bill talks about: "There is, however, a vast amount of fun about it all. I suppose some would be shocked at our seeming worldliness and levity. But just underneath there is deadly earnestness. Faith has to work twenty-four hours a day in and through us, or we perish." (The Big Book of *Alcoholics Anonymous p. 16*)

Because our lives do depend on it. Two Londoners, two young Dutch, and a Dutch woman were there to share their experience, strength, and hope. The food was good and gracious Lord, were we on the same page!

I really don't want to perish. My life depends on full measures, full program, full on, and I know it. And the book tells me "create the fellowship you crave" (p. 164) and I heard a C.A. old-timer talk about

the buzz, nodding away – yes, I am with you, I too crave and need and want that buzz. I had worked all the steps with a sponsor, finished my amends, was living based on the principles of the whole beautiful 12 Step program, but it was not enough. I did not have a homegroup of other addicts with the same deadly earnestness. Not yet.

Next thing I know is I am married to a CAUK service junkie, I am sponsored by a CAUK member and my husband and I decide to commit to doing what we can to carry the C.A. message in our own community here in Germany.

Thanks to a Swedish addict mentioning how the European assembly coming to Stockholm gave his Area a vital boost, we organized the first German event 2015, hosted the European assembly in Frankfurt, received so much C.A. love and a similar awesome boost. Today we are preparing our second event. It's young and raw and vulnerable and great and it just doesn't get boring.

I am not a Pandora's box of entertainment event experience, but a couple of little things I have noticed may be worth sharing.

Just these last weeks, it seemed like the enthusiasm for our second event was not yet there. We spoke about budget and insurance and it felt a bit dull. We could sense new group members go skeptical if the event will be worth the effort.

And then in our committee meeting last week, the lights went on! It was almost tangible. We looked at our first draft for the projected balance sheet and at our upcoming Area agenda and God showed up when one of us said, hey look, whatever profit we will make at the Unity Day in May, we'll send that to Area of course ... and then Area will have a budget to work

One big eye-opener for me has been how these events have set us in motion onto a forward time line, us addicts, who once had only the next hit to live for, who once talked the talk of "power of now" as a pitiful excuse to go stealing and using now-now-now. NEVER A DULL MOMENT

I always thought I knew how to party. I thought I was having fun. When I was using drugs and alcohol, it would start out as fun but always ended with pain, guilt and shame; feelings of remorse. I was the person that liked to drink and smoke and play cards and dominoes. I liked to talk crap to the losers and laugh and joke. To me, this was fun. Even in my addiction, I would throw big parties for my relatives and close friends. I can remember hosting a big party at this club for my husband, brother, and a few others who shared the same month for their birthdays. I spent the whole day cooking for over 50 people, but when it was time to show up to the party I was stuck. I had been getting high towards the end, knowing that I was supposed to be getting ready. Even knowing that, my mind kept telling me "just one more and I'll go after this". That "just one more" never ended for three days. I had to finally go home with my head tucked between my tail, not wanting to face anyone. My children, my husband, my brother, everyone looked at me and I could feel the chill run down my spine. I knew they hated me, and I hated myself. This was just one time that I didn't show up; there were many more to follow. I remember not showing up for my sons' graduation, track meets, baseball games, and football games...anything that was important to them. I was too selfish. All I cared about was the next high and how I was going to get it. It didn't matter if I had to lie, cheat, or steal from someone, as long as I was successful in getting my drug. It was all about me and what I wanted. I was a pitiful mess.

It wasn't until January, 2005 that I realized that my life was leading me into an early grave. I had gone from a size 14/16 to a size seven and didn't noticed that I was that small. I remember looking in the mirror one day and scaring myself. There was a monster looking back at me; dark rings around eyes that were sunk in and skin so ashy it scared me. I recall shrinking away from the mirror, peeking to see if the monster was still watching me. That monster was me. Finally, I reached out to God and begged him to please help me. I knew then that I didn't want to live like that anymore. I know if I scared myself, my children had to be terrified of this horrible looking creature. It was then that I made a decision to let God into my life. That was the beginning of my new life.

The best decision I ever made was to go into treatment. I knew I needed an inpatient program because it was too easy to walk out those doors and get loaded. I began a new life and met a host of new friends. I began going to conventions, parties, dances; all clean and sober functions, having fun. I didn't know what fun was until I came to Cocaine Anonymous. Here were people, addicts just like me, having more fun than I ever dreamed of. I began meeting people from all around the world. I have had the time of my life with people I would have never even socialized with. Life is awesome for me now. I have many friends that love me and want to be in my presence. I can remember a time when that wasn't true. I can say that life is a great big party today. I didn't know what fun was until I came to Cocaine Anonymous. I'll end by saying one thing; Ain't no party like a C. A. party! I will be a member until my last breath!

CONFESSIONS OF A BIG BOOK SPONSOR

I am a Big Book Sponsor. I practice the 12 Step Program as outlined in the Big Book of *Alcoholics Anonymous*, the original recipe for recovery as practiced by the original 100 who recovered from a seemingly hopeless state of mind and body.

By working the Twelve Step program as described in the Big Book of Alcoholics Anonymous, I have had a spiritual awakening. The obsession to use cocaine or any mind-altering substances has been removed. My progressive addiction illness has been arrested. My disease has been placed into remission. I have recovered from a seemingly hopeless state of mind and body. As a result, I am able to remain, almost effortlessly, abstinent from cocaine and all other mind-altering substances. I have ceased fighting anything or anyone, even cocaine. My sanity has been returned. I am not fighting temptation, nor am I avoiding people, places and things on a trigger list. I feel as though I had been placed in a position of neutrality safe and protected by a Higher Consciousness. I have not even sworn off. Instead, the problem has been removed. It does not exist for me. I am neither cocky nor am I afraid. This is how I react so long as I keep in fit spiritual condition. Furthermore, by living in the disciplines of Steps 10, 11 and 12 everyday, I have a daily program of action that really works in rough going. I have way of living without cocaine or any mind-altering substances.

You can recognize me at 12 Step meetings because I am armed with the facts about myself. As an ex-problem addict, you will see me making an approach to the newcomer—looking for someone who is open-minded about our common solution—someone with an honest desire to stop using cocaine or any mind-altering substances—someone who wants what I have and is willing to follow the instructions as outlined in the Big Book—someone who wants to be joyous and free of active addiction.

To show other addicts precisely how I have recovered is the main purpose of this book. I carry a common solution—a recipe for recovery on which we can absolutely agree and upon which we can join together as brothers and sisters in harmonious action. My deportment shouts that I am a person with a real answer. I carry no attitude of Holier Than Thou. I do not talk down to the addict from any moral or spiritual hilltop. I ask for no payment. I have no axes to grind

nor people to please. You can expect to endure no lectures from me. My only desire is to be helpful. I offer friendship and fellowship.

I have carried the message of the Big Book of Alcoholics Anonymous to many addicts and rarely have I seen a person fail who thoroughly follows our path. But untreated addicts are unlovely people. My struggles with them are strenuous, comic and tragic. Those who could not or would not see our way of life are often consumed by their temptations which leads them to the gates of insanity or death. Helping other addicts is the foundation stone of my recovery. A kindly act once in a while isn't enough for me. I have shared time, energy and money. My business and personal life has been interrupted by the telephone ringing at any time of the day or night. My spouse sometimes feels neglected. I have made innumerable trips to police courts, detox centers, hospitals, jails and asylums. I have counseled frantic spouses and relatives. Occasionally I have to meet such conditions.

I have worked hard with many addicts on the idea that only an addict can help another addict. I have had many failures. I often hear that this is a "selfish program", but whenever I put my sobriety first I could never stay sober. When I started showing the newcomer how to stay sober, I have found no trouble staying sober. As Doctor Bob once remarked, "strenuous work one alcoholic with another was vital to permanent recovery."

Sometimes I am confronted with Big Book of Alcoholics Anonymous animosity, but my program tells me I have to look at my part. Have I been crusading, righteous, or critical? Have I been engaging in frothy debates or windy arguments? Have I been demonstrating an attitude of intolerance? Yes, there have been times when I have been all these, but I claim spiritual progress not perfection and I am no saint. I must remember that when I focus my mind on what is wrong with the fellowship and the meetings today, the more I become restless, irritable and discontented. I must remember that the meetings are filled with many suffering and untreated addicts. Love and tolerance of others is my code. So, I practice acceptance and focus on what is good about the meetings and the fellowship. I try to see what I can positively add to the meeting my only desire is to be

helpful. I must remember that I have no monopoly on recovery, but I do know that the Big Book solution works.

Why do I continue to work with other addicts?

Having had a spiritual experience, I try to practice the 12 Step principles in all my affairs. First, I take care of family, for sobriety is not enough and I am a long way from making good to my spouse, parents and children whom for years I have so shockingly mistreated. Second, I take care of my business, for there can be no family if I am not self-supporting. And third, in my spare time, I carry this message to other addicts. For me, this approach, in this order, is a balanced program.

Over the years I have witnessed a fellowship grow up about me. I have watched the spirit grow in the eyes of a suffering individual and seen them recover from a seemingly hopeless state of mind and body. I have seen them make a 180 degree turn in life, only to help some other suffering addict do the same. This is the experience I would not miss. I know you will not want to miss it either. Frequent contact with newcomers and with other Big Book sponsors is a bright spot in my day.

My life has taken on a new meaning and I seem to be of benefit to others. I have found a new freedom and happiness. I know serenity and peace. I continue to lose interest in selfish things and gain interest in the people in my life. My attitude and outlook on life has changed. Fear and economic insecurity is down and I know how to intuitively handle situations which use to baffle me. I realize that my Higher Power does for me what I could not do for myself alone.

Thus I grow spiritually and so can you with a Big Book in your hand. It contains all you will need to begin working with the addict who still suffers. I know what you are thinking, "I'm a newcomer myself and I do not have enough clean time to be of use to anyone. What could I possibly offer another newcomer? Maybe I should wait a year or two." Rubbish! By working the Big Book solution, you will tap a source of power greater than yourself. To duplicate, with such backing, what I have accomplished is only a matter of willingness, patience and labor. Remember your reliance is always upon your Higher Power. It will

show you how to create the fellowship you crave. Ask in morning mediation what you can do for the addict who still suffers. The answers will come if you work your program. But if you are shaky you had better work with another addict instead. Remember you have recovered and have been given the power to help others. You will soon find out that when all other measures fail, work with another addict will save the day. Give freely of what you have been shown and join us on the Broad Highway of the Fellowship of the Spirit. You will surely meet some of us as you trudge the Road of Happy Destiny.

Trust God, Clean House, Help Others.

SOME CHARACTER DEFECTS LAST LONGER THAN OTHERS

Some character defects last far longer than we would like. I recently attended a seminar where they were discussing how we (as people...apparently this is not unique to addicts!) operate largely on "Looking Good/Avoiding Looking Bad." This is something that plagues my life. I have known this for years. It shows up all over my Fourth Step (fear list). Heck it shows up all throughout my Step-work. Here I am with two decades of sobriety and it can still paralyze me. The seminar assignment was "Find some area that is important to you where you are stuck inside of looking good/avoid looking bad, and cause a breakthrough in that area. Some ways to go beyond looking good include honoring your word and taking actions that are consistent with your stand, cleaning up messes that you made inside of looking good, and communicating with others what is really there for you." The area I chose was 12 Step meetings.

I had pretty much stopped sharing in meetings. I especially disliked ticket and tag meetings. I would get so worried I would get called on that I obsessed on it and thought only about what I would share. I could barely hear anything that anyone else was sharing because my internal dialogue would not shut up.... until I get called on... then it had NOTHING TO SAY. My mind would go blank, because I became full of fear. I would worry about what you would think of me. I would worry you would think I am not working a good enough program. That I am not good enough. Not spiritual enough. Or worse, that I don't belong. All of this is nonsense, of course. I know a lot of you like me. I do work a good program and I have a good relationship with my Higher Power. I most definitely belong in the rooms. Yet my internal dialogue wants to debate this. Wants to tell me I don't have anything of value to share. Wants to tell me that if I share someone will share after me and say that I have it all wrong and don't listen to me. And then I would look bad, when all I want is to look good! LMAO. So crazy!

I have been opening up in the meetings. Being authentic. Telling them (and you) that you all scare the crap out of me! LOL I tell them about the evil committee in my head. Funny how when we share it starts taking the power away from the insanity. Its kind of hard to do when sharing IS my insanity!!!

Now I practice really listening to others and not so much to the dialogue in my head. Being present for others. Opening up, whether it makes me look good or not. I have learned that I can create my life. I can leave the past where it belongs and stop bringing it into my future. I am creating the possibility of being inspiring and extraordinary! I know I can be. I know I am. I am putting these old fears behind me. I am leaving them in the past, where they belong.

MY DELEGATE EXPERIENCE

I am a long-time member of the Online Service Area. I served the Area some time ago as a GSR for one of the meetings for a short time but really never quite understood the purpose of having delegates. One reason is that it was never quite explained to me; the other was that I was never exposed to the annual World Service Conference since it is always held in Los Angeles. In this digital age we really don't need to be locked in to the LA Area. Someday, I hope they will move the Conference around from time to time allowing other Areas and Regions the opportunity to see what really happens at the WS Conference and they even the newest member has the ability to walk up to the microphone and participate.

My original belief was that it was just another free trip for people and that impression wasn't changed by the delegate reports I read post-conference. It seemed like most of the reports centered on gratitude and how wonderful the Fellowship experience was, that a lot of work was done but no real understanding of what the whole thing was about. When I was nominated for the position I was still very skeptical but was reminded of "contempt prior to investigation." I decided to go in with an open mind.

My first Conference I attended as an Alternate Delegate with one vote. (Our delegate was unable to attend). We laughed, we argued, we voted and we always walked away confidant that we did our best to represent the needs of the Fellowship. This year I finished up my term as chairperson and passed on the responsibility to Jerico M.

Having completed my term as delegate for the Online Service Area I am a changed man. While there are certainly some things that I think need to be changed, I have no doubt that God is truly in charge of this fellowship and that the conference does answer the needs of the Fellowship. As I turn my focus on to helping my local Cocaine Anonymous Area, I'm truly grateful to the Online Service Area for supporting me through this whole process and allowing me to be of service. As I finish this report I'm reminded of what Dr. Bob wrote about service: I spend a great deal of time passing on what I learned to others who want and need it badly. I do it for four reasons:

- 1. Sense of duty.
- 2. It is a pleasure.
- 3. Because in so doing I am paying my debt to the man who took time to pass it on to me.
- 4. Because every time I do it I take out a little more insurance for myself against a possible slip. (Big Book of Alcoholics Anonymous, page 180-181.

If there is one thing that I have learned over the course of my sobriety it's that I have no laurels to rest on, just the next commitment.

I had about six months sober. I was living in a half way house in Scottsdale, Arizona. My entire life was contained within a three-block radius (work, the meeting hall, and the halfway house). My roommate had heard about an event called the Apache Lake Roundup. He described it as a bunch of sober people who were going to be camping together and having meetings. We packed up his car with some jackets, old blankets, and a tent we found in the closet (which happened to have broken poles) and drove out. That night, I watched as people emerged from every direction to come to the large speaker meeting. After the meeting around 200 people circled up under the night sky to say the closing prayer and I felt truly connected. The next morning we ended up on a boat with about nine other sober people (all but one of whom we didn't know). We spent the whole day on the water exploring, swimming, and jumping off cliffs into the lake. This experience was the first time I saw a large group of sober people having fun. It was a truly amazing experience and the people I met at that event led me to a meeting that would ultimately become my home group.

Since attending that first C.A. event, I have been involved with many conventions, round ups, and retreats. I was fortunate enough to serve on the 2011 CAWS committee (In Phoenix, Arizona). At the time of the convention I was preparing to move from Phoenix to Chicago. I was able to meet some members from the city that was to be my new home, so that when my wife and I arrived in Chicago a few months later, we were already connected. We immediately joined these guys serving on the Illinois Area Convention Committee and took up positions. We've continued to serve on C.A. committees in Chicago ever since. When the opportunity came up to serve on the CAWS 2016 committee I submitted a resume and was chosen to be the Program Chair. Service on C.A. committees has given me the opportunity to give back to the program that has given me so much, show the newcomer how much fun they can have in sobriety, and meet people from all over the world.

NEWSGRAM LETTER TO THE EDITOR:

Back in the First Quarter, 2015, I asked the Fellowship if they would be interested in a "Letters to the NG Editor" portion of the NewsGram. It was, and is, to be a place where members of the Fellowship can disagree, or comment on something that was written in a previous issue. This is our first Letter to the NewsGram Editor. This is in regards to an item that was in the 3rd Quarter, 2015 NewsGram Issue entitled "Does Group Autonomy Trump the Traditions?" Here is a response:

Hi family -

As a former trustee, I have embraced new roles of service in my recovery and support the new representatives of our Fellowship at all the levels of our service structure. As an elder statesman, I have watched and reserve my opinion in most cases to allow the spirit of our World Service Manual, Twelve Concepts and Twelve Traditions to guide the service related decisions of our Fellowship. But there are some exceptions to this silence when I believe the information we give our Fellowship to make informed decisions is questionable.

In the third quarter Newsgram, there is an article entitled "Does Group Autonomy Trump the Traditions?" The title itself grabbed my attention as the group's autonomy IS the 4th Tradition. Upon reading the article with some confusion as to the content, I reminded myself of the beauty of each member's opinion regarding questions such as these. And I don't want anyone confused as to my understanding that the rest of this article is only my opinion as well.

The crux of the issue in my opinion is what is and what isn't C.A. Conference approved literature? And does C.A. take a position regarding the utilization of literature that is not C.A. Conference approved for our members and in our meetings?

Specific to the little Red Book (containing the first 164 pages of the Big Book of *Alcoholics Anonymous* published by Anonymous Press) being used by some H&I groups:

I was part of the H&I subcommittee in Arizona back in the day when the decision was made to use the area's generosity to the H&I can to distribute the first 164 pages of the Big Book of *Alcoholics Anonymous* to as many addicts confined to hospitals and institutions as we could. Discussion on the subject was informed and the voices for all the angles were heard. With approximately 100 H&I meetings each week in Arizona, the expense to provide the Big Book of *Alcoholics Anonymous* to those individuals or the little Red Book to seven or eight times as many was discussed. The loyalty to A.A. vs purchasing literature from another organization was discussed. Possibly removing the back pages of the little Red Book to remove affiliation concerns before distribution was discussed. The "approved" or "not-approved" question addressed above was discussed. Does the choice of either avenue of purchasing the literature affect C.A. as a whole was discussed?

Any individual's position or concerns were allowed to be brought forward and discussion was fair and informed. The decision was our Area would provide the Big Book of *Alcoholics Anonymous* to our regular meetings where our members are most likely to purchase the book themselves and the H&I committee elected to provide the little Red Book to the confined addicts free of charge. The result of that action was, and still is, truly in the spirit of our 4th Tradition and I support the areas across our Fellowship to have their own discussion.

I love our Second Tradition: For our group purpose, there is but one ultimate authority – a loving God as he may express himself through our group conscience. Our leaders are but trusted servants, they do not govern.

I don't believe it's my role to convince anyone on which way they should vote on the issue if it was before them, so I don't believe it's my role as a former trustee to dictate which way would be right or wrong. But I do believe it's our roles as members of this Fellowship with some experience to educate and inform our Fellowship. I believe in the Steps, Traditions and Concepts of our Fellowship and can only pray that Bill's fear for his Fellowship doesn't become a reality for ours.






