### HAVING FUN IN RECOVERY

I started with C.A. in Mid December 1986. I got out of treatment November 30<sup>th</sup> and was crazily going to meetings of other Fellowships that said they were closed and that I could not talk of my drug addiction, or they would not allow me to share until I had one year of sobriety. I was warned in treatment that I needed to get involved in 12 Step recovery program and that learning how to have a good time without drugs was critical for me to stay sober. My first C.A. meeting was "Hollywood Hoovers" on Sunday night in Portland, Oregon. There were 30 to 40 people in attendance and they talked about all the things I could relate to about my "cocainism." There were designated greeters for newcomers and many of them went for coffee, pie or frozen yogurt after the meeting together. I think there were about six meetings a week in Portland at that time and I went to all of them for several years. I do not think I missed a Hollywood Hoovers meeting for five years.

We had a few events when I arrived, like speaker meetings with food, bowling and dances at a sobriety nightclub called the PASS Club. I attended all of the events, but it was hard for me. Even though I was 35 when I got here, I was painfully shy and fearful to ask someone to dance. After standing with my back against the wall watching others dance a nice lady named Laura asked me to dance. I taught her how to dance the swing (that was how I used to meet ladyies in bars while listening to country rock bands in the late 70's and early 80's). Then I got too paranoid and I couldn't go to those places anymore. It was fun to dance. I was convinced that nothing would ever be fun without drugs and alcohol when I got sober – I was wrong.

I was not really excited about the music they played, as it was not in my "wheelhouse" so-to- speak.

I was into country rock, hard rock and rock and roll. Now, as I look on my IPhone now, almost all the songs are from the mid 80's, after I got sober. I still know the old Zep tunes and others, but my favorite times are in the 80's and 90's when I was sober.

I liked live music and asked my new C.A. friends why we didn't do live music instead of the recorded stuff? There were a few answers, cost being one. They had tried some bands and nobody would come and support the event. They even said nobody dances anymore (I found it hard to believe that no one ever danced but me). OK, this looks like a job for Baseball Bob to show his party skills from years gone by!!

Let's analyze their reasons, who were the bands that nobody would support? OK, these were, at BEST, garage bands that often times could barely play a song all the way through and didn't even know the words. After two songs, everybody left for better things to do. If I were drunk or high I wouldn't go either.

Answers: Top bands often do favors for good causes. Many have had friends die of drugs and alcohol. When we watch a bad band we are sober and are acutely aware of how bad they are.

This touches on cost. Bands will do special deals, but only when they can do that without affecting their ability to pay their own bills. I used to go to a couple of events at an old Portland tavern. On Memorial Day and Labor Day weekend they used to get five of the area's top bands on the same night. There were usually 1500 to 2000 people at these events. Good bands get paid good money on Friday and Saturday nights. Bands are not usually booked on Sundays and on a three-day weekend most folks don't have to work the next day. We got a sober club to give

us their large hall for \$100 because they liked the atmosphere that they enjoyed from having our membership around. If the band is good, you might even think dancing was kinda fun too.

There was a player on my C.A. softball team who new the drummer of a nationally known Blues Band. We approached them and they agreed to do our gig for \$300. This was actually the cost of renting an appropriate PA sound system for the room. We announced it at all our meetings and asked some of the other Fellowships and Clubs if we could promote a clean and sober event via flyers on their bulletin boards. It was amazing and is probably why we grew so much in the first five years of our Fellowships existence. As I recall, we used to get about 800 people at our event. The music was great; the faces of all the attendees were enough to warm even the coldest of hearts because of all the smiling dancing faces. We were able to pay our expenses and donate over \$4,000 to the Fellowship as well. Even the band loved it. They immediately agreed to do it again the next year. We called it "Blues Sunday" and although it is no longer with us it worked and was a major part of making C.A. recognizable from the other 12 Step Fellowships in our area for many years.

We started to play competitive softball. There were about a dozen other members of C.A. that felt the same way. We started a C.A. team. We were good. We had fun. I didn't think I would be able to play when I got out of treatment. It was the most fun and rewarding experience in my 20+ years of playing the game. Because I wasn't wasted, it of even been the best I ever played. I discovered I could still go fishing clean and sober. I caught more Salmon and Steelhead too. We started having picnics, campouts, had our first Oregon Area C.A. Convention. It was a source of pride and something for our H&I committee to talk about in their visits to the treatment facilities. People wanted to come to C.A. and be a part of this special fun Fellowship.

Thank you for being there for me. And thank you for letting me be of service!!!

It was fun to write this NewsGram article. It helped me to remember! Maybe I will try it again and talk about scuba diving and hang gliding and convention hopping!!! There are so many great things to do once you are clean and sober.

### MY TRUSTEE ELECTION COMMITTEE (TEC) PROCESS EXPERIENCE

Two years ago at the 2013 World Service Conference in between the committee breakout sessions, I remember seeing a couple friends who looked like they had been run over by a dump truck. They looked slightly dazed and definitely frazzled. I asked what they were up to. They only said a few vague things to explain they were on the TEC, had arrived a couple days earlier for some meetings, and said they had never experienced anything like it before. They also said was an amazingly positive experience for both of them.

In 2014 when I was nominated to be on the TEC, I was shocked. I was even more shocked when I was selected to represent our Region on the TEC. I thought it was kind of funny as I had never held a service position where you didn't do anything in that position but show up for the next year's meetings. I decided to show up early to this year's Conference, excited and scared at the same time. I wanted to make sure I was settled and rested, ready to serve on the TEC. I really did not know what I was doing there. I know I had spiritually prepared myself to be ready for whatever God wanted. I have to tell you that, boy, did He deliver.

Initially, when the TEC first met in the boardroom together as a group, I did what I tend to do. Usually I judge everyone in the room and then feel less than or better than others in the room. It takes me a few moments to find common ground and then remove my fear, judgment and ego. When it was time for comments, I remember having a difficult time speaking up. The TEC Chairperson said, "It's time to find your voice and quick." Everyone found their voice alright and the TEC election process began.

I have never changed my mind so resolutely so many times in such a short time. I have seen God's work on the Conference floor, in Area meetings, in Committee meetings, in Group meetings and in Step work with sponsees. I have never before felt the large majority of one group in one room so entirely ready to allow God into the process as it was in the TEC. When information came before the group, it would be critically dissected and analyzed. It was crazy to see so many different personalities view the same information so differently. Things got very serious, feelings were hurt and emotions ran high; yet, everything seemed to be in God's hands.

During the selection process, one position is discussed for numerous hours. Eventually, the group anonymously comes to a majority decision and a trustee is selected. However, the group does not know the end result at that point; only the TEC Chairperson knows the actual results. I walked away hoping we had made a correct decision, but I didn't really know if we had or not. It is an odd experience.

After the selection process was complete, we were told we would have a group inventory the next day. Personally, I thought 24 hours in a boardroom as a group was sufficient. I didn't think a group inventory was necessary. That next day, sitting in the room before the start of the group inventory, I thought I had nothing more to say and nothing to process. I was very wrong because I found myself very emotional while others shared their feelings about the whole TEC experience. I was shocked to discover the wide range of emotions and feelings I had about this process and about the people in that boardroom. I left this year's Conference feeling completely satisfied, knowing that I had one of the most spiritual experiences in my service career.

I take the Steps and get introduced to myself and learn to live and even love me. I use the Traditions and really get to know, appreciate and love you. Then there are these pesky Concepts of Service that really help me to join in brotherly and harmonious action with you.

So what I really want to speak on is Service. But for me I can't just jump right to service without combining Steps and Traditions. The definition I like most about service is; to be of use or benefit to someone else. I would hope that my life as servant to Cocaine Anonymous would reflect me as being useful. I cannot be useful until I am trained to be useful. The Steps take me from being useless and of no real help to others to someone that can be useful. There are Traditions that help me in these group settings (Home Group, Area business meetings, World Service Conference). Our service structure is not something I become experienced with just because I took some Steps or studied some Traditions. I remain teachable in learning the process throughout our wonderful structure of service. I realize that being right is not as important as being effective. I learn that to listen a little longer may gain me some more understanding. I learn that my teachers are not qualified merely by a sobriety date. If I believe that we are all volunteers then I must concede that we all want what we believe is best for the Fellowship - If I believe that, then it reduces my resentments also. So to that point, no, we cannot nor should we all get

along All Of The Time. But when the vote is complete, one must then consider that even though not in agreement it is then time for us to join in **Brotherly and Harmonious Action**. So then there is a time for us to All Get Along.

So in conclusion I must look at my own belief system and learn to respect yours. When I respect your right to have a different opinion and viewpoint, see your shortcomings as a possible reflection of my own, then I can relax and trust God to sort this thing out. Sometimes Quickly, Sometimes Slowly, but always.

### RELAPSE WAS UNTHINKABLE...WHAT HAPPENED?

Having worked with addicts from all over the world, the reasons for relapse amongst those with sobriety time seems to always point to same reasons—they stopped working their program of action. This article is a synopsis of their stories.

I got clean and sober working the Twelve Steps and that was a miracle in my life, because for years the only thing on my mind, morning, noon and night, was how do I get high, stay high and get higher. The desire to drink or use drugs was gone. Life was great. Family relationships improved. I started working again and I even made a little money. Then I went on cruise control. I got cocky and complacent. My program began to waver.

The first principle I let go of was unselfish work with other alcoholics and addicts. This was my Twelfth Step. Intensive work with other alcoholics and addicts was too strenuous. I was too busy to carry the message, so I stopped working with newcomers and having fellowship with other recovered alcoholics and addicts.

Next to go was Step Eleven. First, I stopped meditating (listening to God) and eventually I also stopped praying to God. My conscious contact with God diminished. What used to be an intuitive direction became muddled confusion.

Next, Step Ten ceased to be part of my daily routine. Why bother with the minutia of daily life. I stopped watching for selfishness, dishonesty, resentment and fear. I stopped asking God for guidance. I stopped discussing my shortcomings with others. I didn't bother to clean up my mistakes or make amends for my wrongdoings nor did I bother to turn my thoughts to someone I could help.

When I quit working my daily program of action, my spiritual fitness began to wane. I no longer had a burning desire to clean up my past and set matters right. I discarded my Step Eight list of people I had harmed and ceased to make any further direct amends as suggested in Step Nine. Guilt, shame and remorse over the things I had done in the past began to creep back into my thoughts disturbing my peace of mind and serenity.

When I gave up prayer and meditation, Step Seven ceased being a part of my evening prayer and meditation. I no longer asked God to remove my defects of character nor did I ask God to give me

strength to be honest, pure, unselfish and loving. With that, I ceased doing Step Six. I failed to see the futility and the fatality my character defects and their terrible destructiveness. My shortcomings were no longer objectionable and I became unwilling to let them go.

I no longer confessed my shortcomings with others (Step Five) because I also stopped taking a fearless and moral inventory of myself (Step Four). Resentments, fears, and harms to others began to pile up and I once again I became blocked from the sunlight of the spirit

Next, I stopped doing my Step Three morning prayer and meditation. I no longer turned my will and my life over to God. I had better ideas. A hundred forms of fear, self-delusion, self-seeking and self-pity drove me to selfishness and self-centered behaviors.

Next, I gave up searching for the great reality deep down within me. I became unwilling to believe in a Power Greater than myself. I lost my Step Two and lack of power became my dilemma once more.

Without power, I had no defense against the first drink or drug. My sound reasoning failed to hold me in check. The insane idea won out. All had gone well for time and relapse was unthinkable, but I failed to enlarge my spiritual life and to my consternation, I found myself high in a very short time. I was once again powerless over cocaine and all other mind altering substances and my life had become unmanageable. I was back on Step One.

Recovery is not a short sprint...it's a marathon for life!

It has been my experience from working with hundreds of addicts around the world that most untreated addicts will fail because "half measures avail us nothing". Easier softer ways often prevail and many are baffled as to why they relapse. Ultimately, if they be an addict of the hopeless variety, it's because they do not thoroughly follow our simple program of action.



### ONE LAST CHANCE

"Living Free Group" – Monroe Corrections Complex Monroe, Washington, USA

For the last four years I was in an out of state private prison in Arizona. I was able to share time with my wife and sons who lived nearby. I was returned to a prison in Monroe, Washington and left my family in Arizona. I felt totally lost. I had been sober for a few years, but I wasn't working a program. I'd spent the last 17 years in prison but never felt so alone or afraid as I did at that moment. I hit a bottom I didn't know existed! Then one night I stood on the big vard praying for help, my Creator showed me a sign, (a pack of covotes singing to me, from the hillside outside the wall) a sign that I could not ignore. The next morning when I woke from a restless sleep, I got out of bed and went to the yard to run, which was the only thing that allowed any type of serenity in my life at that moment. After running for hours, I went back to my spot in the yard to pray. Standing in the same spot feeling the lowest my spirit had ever felt, my prayers reached up to the east, I prayed as tears ran down my cheeks, "Oh Creator, I am lost and confused, my soul is sick and my heart is sad. I am not sure I can go on. Please show me the way back!" As I opened my eyes I witnessed something that I know now as a, "God shot." A huge male bald eagle swoops up and over the chapel and flies over me, not ten feet over head. Then all at once he pushes backwards with his massive jet-black wings right above me! I swear to this day he looked into my soul. I thanked him. I knew I was holding on too tight and trying to do everything on my own. I knew that if I kept my spirit open that I would receive my answer.

Later that night my cell door open, I stepped out to ask what this is for. The guard said, "You're on for A.A." and I thought, "What the hell, I don't have anything else to do."

It's funny, for the first time in almost a month I felt more relaxed than ever as I walk into room #2 of the Programs Building. Then those old fears came rushing back as I saw inmates and outside sponsors. With the outside sponsors were a couple of ladies, it surprised me to see women here in the prison. A guy walked over to me with a big smile and held out his hand. I took his hand as he introduced himself. "Hi, I'm Frank!" he said in a very spirited and up beat voice.

I sat down and when I looked up I saw Frank looking over at me smiling. There was something about this guy. Again I thought that maybe I did do time with this guy somewhere. The other guy who told me about the coffee now came by passing out these laminated cards, and asked if I'd like to read one for the group. I took one of the small cards and which had Step 7 and Tradition 7 on the other side.

I heard someone new speaking, "Hi, my name is Scott your chairman. Welcome to Alcoholics Anonymous." Everyone said "hello." We then went through and read everything that had been passed out. Then the chairman said, "The meeting is now open." I felt eyes on me and sure enough, Frank was looking toward me and he nodded to me. I settled back into my chair when I heard a new voice, it was Frank "Hi, my name is Frank and I'm an Alcoholic." Everyone said "Hi Frank." He started speaking about his past and how things have changed for him. How happy he is because of this program. Then he said, "You know it took a lot of hard work for me, but it all started for me right here in this room. Years ago, I sat right here in this room as a convict, I heard an old timer say "you only have to change one thing if you really want to turn your life around."

I thought, "Hell that should be easy!"

Then with a booming voice, Frank continued, "You only have to change EVERYTHING!" He had my attention. So I listened to him speak for the next ten minutes or so. I thought, "Man, this guy is just like me, high strung, full of energy, lots of body movement as he speaks." The more he spoke, the closer I listened from the edge of my chair. Then I realized I had previously done time with this guy. After the meeting, Frank and I talked for a few minutes. He thanked me for coming and he hoped to see me next month. As he shook my hand I felt such positive energy and knew deep inside he truly meant it.

That night as Frank spoke I felt that same connected feeling to him, hanging on his every word. I thought here is a guy who has done 20 years, and got sober in here. He changed everything about himself in prison and now years later, he is coming

back into the very prison he did ten plus years and started working his own program! Frank says tonight, "I come back here for a selfish reason. See, this is the room that saved my life. This is still my home group. It will always be and I am truly grateful to be able to do this meeting again. Other members told me that the only way for me to keep this is by giving it away! I enjoy coming back in here because it is a reminder to keep working hard on myself and my program, so I NEVER have to come back to this place!"

One night Frank says, "Hey, I want to work on starting a new meeting here for you guys if you would like. You see I am heavily involved with another 12 Step organization called **Cocaine Anonymous**. I attend those meetings the most now. It isn't just about cocaine, there they don't care if you drank, smoked, shot or popped! It's just about our recovery and what you want to do to change your walk in life today. We are just here to help one another and we'd like to bring the first C.A. meeting ever to Monroe. It will be the first C.A. meeting in Washington prisons if you want it?"

Of course we did! Over the next six months, Frank talked and called the people in charge at the Prison. Now here was an ex-con that did time in this prison, doing whatever it took to help guys out back in here at the very prison he'd been in. Most would think, "Why would a man who did so much time in prison want to keep coming back, and spend even more time here?"

So, I asked Frank one night after the meeting. I said, "Frank, why do you do so much and continue to work so hard for us in here? And why do you keep coming back in here?"

Frank smiled and replied, "It reminds me where I once was and never want to come back too. And if I don't continue to give this back, I could forget real easily who I once was and how I got here to start with. This is the room that saved my life, and it's what others that came in here before me did for me. Remember, we can only keep what we have by giving it away."

After that day I never questioned him again or had any doubt about what I needed to do myself. I took what he said to heart and since then did the best I could to apply it to my own recovery and everyday life.

About a year later we started our first C.A. meeting! It was the first C.A. meeting in Washington State prisons. I often wonder how many there are in the prison systems throughout the country.

We all were very excited. But to see the light burning so brightly in Frank's eyes that day was a gift in itself. His soul radiated with so much energy and honor! This man took more time out of his life to help anyone and everyone who walked through these doors. He didn't care about race, creed, or what your background was. His hand was there to greet you and share with you his story, strength, and courage. He was truly happy to see new and old friends he'd made over the years in this room.

Now and then Frank is unable to make it in to all the meetings, because he has a life out there and other life commitments he must take care of. But his wife and many other members take their time to always drive down here for every meeting to make sure we get to have a meeting. Frank always sends his respects and love to us. In his own way he knows what it means to have these meetings and being a part of that is important to him. I often wonder at times if he realizes how important he is to me and to the hundreds of men who come into these rooms. Even if just a few of us really hear his message and I mean really hear it! No matter, because to me Frank is my hero! He's helped save my life and I hope one day I can do as he's done for so many. Just give back what he gave so freely to me. What a great man he is. I look forward to seeing him and hearing him speak about Hope, Faith, and Courage in this program. Year after year I grow in my own program and walk in life because of him and so many others that he's brought in for them to share their Hope, Faith, and Courage with us.

We are coming up on our fourth year anniversary for our first C.A. meeting and we just lost one of our sponsors yet through it all, we found strength within each other. In the last few months Frank J. has been here and as always I sit on the edge of my seat as he speaks or one of the other great members who grace us with their story and/or knowledge hoping to hear that one thing that might help me today in my program. I'm truly grateful for all they give to us all.


To me, Frank is my pot of gold to my recovery and freedom, which I too will give away freely to others.

# Big Book of *Alcoholics Anonymous*Page 564 Seventh Tradition

The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholic Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority.
