SPIRITUALITY

Hi! My name is Richard and I am an alcoholic and drug addict. I have been in recovery since 8:30 PM on September 19th, 1982.

It has been suggested to me that the topic of this article be, "Spirituality." I have been contemplating this topic for about two weeks now. I was a little overwhelmed by the thought that this is a topic that can be different for every single person that thinks about it. With that in mind, I found myself in need of a little help, I asked the God of my understanding to please help me so that it not feel so overwhelming. After asking, my very next thought was what I believe to be a Godsend. That thought was simply, "Keep it simple." That thought grounded me and it made me kind of chuckle and smile when it came to mind. The feeling of being overwhelmed subsided and things began to come to mind that are of a great help for this writing.

Just to get a clear picture in my mind of what Spirituality means to myself and maybe a little more understanding, I searched the definition of "Spirituality." The definition I found was as follows: *Spirituality is a broad concept with room for many perspectives. In general, it includes a sense of connection to something bigger than ourselves, and it typically involves a search for meaning in life. As such, it is a universal human experience—something that touches us all.*

Well, That definition certainly makes sense to me, and seems that it was a clear and simple statement.

Just to try to give a sense of what my personal journey has been to date. Here are some of the directions that I have pursued to find a more personal perspective of spirituality. I tried Church, attended spiritual channeling's, I have read many books on the

subject from a lot of different cultures and authors. In 1987, I observed what was called the "Harmonic convergence" which was supposed to bring in the "New age." I was also raised in a spiritually open minded family in which it was very normal to consult different kinds of psychics. I worked as a jeweler in a psychic mall. People that practiced the art of reading personal auras, Reiki practitioners, massage therapist's. It was an environment that was very well suited for things like learning meditation, which I also practice to the best of my ability. All the while I was doing this, I was practicing sobriety. I became the secretary of an A.A. men's group that was a Big Book Study on Monday nights. I also attended a *Twelve Steps and Twelve Traditions* book study on Thursday night. I ran a *Twelve Steps and Twelve Traditions* book study for C.A. on Sunday nights at the "Hollywood Hoovers" meeting in Portland, Oregon. I was accepted to a training program to become an alcohol and drug treatment counselor. My training was grounded in the methods taught at Hazelden treatment Center. While in training I was also attending college classes to become a counselor. I was still attending my meetings and working with others. I also went to Arizona for a month to get treatment for Codependency at a treatment center in Wickenburg Arizona. You might be asking while reading this long paragraph, what does all this have to do with Spirituality?

Well, for me it is simple, it has to do in part with "Love." Also, interpreting the feelings from my heart and expressing them with thought. Thought that comes with the blessing of a clear heart and mind. A process that I have to confess I am still (at 34 years of sobriety) learning. I have heard mentioned that

sobriety is contingent on the daily maintenance of a spiritual program. Well for me, the single most spiritual thing I have ever practiced in my entire life? The Twelve Steps as printed in the Big Book of *Alcoholics Anonymous*. Those simple yet complicated, and even hard at times to practice, "suggested Steps."

You see, while practicing those Steps and principals as they are written in the Big Book of *Alcoholics Anonymous*, I started to grow. Grow from the 27-year-old addict I was when I went into treatment and was given this spiritual gift. I have learned to listen with my heart and mind. I have a much better understanding of humility, when I feel it in my heart. An understanding of what it can mean to actually reach out to someone else in need and be able to let the program, as written in the Big Book of *Alcoholics Anonymous*. To put myself aside and let this program work through me. To let go of ego, to be, as humanly possible non judgmental of others and let others make their mistakes without trying to control and or change them. But be there in case they become in need of assistance in their process, to in other words, practice these principals in all our affairs.

The Twelfth Step starts out reading, "*Having had a spiritual awakening as the result of these steps....*" I sometimes get goose bumps when I contemplate all of these things. I get an overwhelming feeling of well being when I am truly being what this program has taught me to be. Which in my understanding is simple. An open-minded servant and person who just wants to get through the day sober today. To me sober doesn't mean just not drinking and using. In my heart and mind, sobriety is a very precious gift that I was given on September 19th, 1982. I will restate the most important part of the last sentence again, "I was given." Strangers handed me this when I was ready to receive it. Sobriety has saved me - my person has been saved. The quality of my life has been changed for the better no matter what malady or challenge I might be going through at any given moment. I have been given so much love in this process that I finally started to understand what love is to me. I have also learned to give it back and give it freely without expectation. I have been blessed with friendships that have been of so very much value that I

have no way to say in words how much they mean to me. This all started with having a "Spiritual awakening." After that awakening I was given the permission to not be perfect in my pursuit of the promises and the rest of life. Also given a way to correct my mistakes and bridge relationships, and in this process, my heart has been undertaking its own mending and I as a person can say I am grateful and know just what that means to me. To me, that is certainly no small thing. I have tears in my eyes at this moment of reflection. That is happening because I am so overwhelmed with emotion that my body simply cannot contain it, so it is spilling out of me in the form of those tears.

In closing, I will say this, nothing else in my life in any part of my life has been a more moving or greater spiritual experience aside from one single thing that I can think of: In 1980, my Son Joseph was born. After his birth, I was in the lobby of the delivery rooms of the hospital. I was standing in the hallway when a nurse walked up to me. She was holding something in her arms. She then looked at me and asked, "would you like to meet your son?" I then apprehensively walked over to her and she took the cover off of my son's face and she held him up close so I could get a really good look at him. This may sound corny, but it was at that moment that it seemed to me that everything around me just stopped. No noise, I could not hear anyone speaking and I was just not aware of anything going on outside of the introduction of this little baby boy. He was the single most beautiful thing/person that I had EVER seen in my entire life and still is. I have never had another experience like that. In that single moment, I learned what it was to feel like my life did not matter and that I would choose in a nano second to give my life for that little seven pound person in that nurse's hands. He was born two years before I got clean and sober. So, without hesitation, I can honestly say to anyone who reads this. I have been given two gifts in my life that no other gift can even begin to equal. My Son and my Sobriety. In both instances I had a spiritual experience.

MY DESIRE WAS NOT ENOUGH

Tradition Three states; "The only requirement for C.A. membership is a desire to stop using." My desire to stop using cocaine was not enough to keep me in the rooms of Cocaine Anonymous. I wanted to stay stopped; I wanted to recover from this seemingly hopeless state of mind and body, but I could not muster up the strength. I lacked the power to choose "life" over "death."

I was naïve. I was sheltered growing up as a child and I did not know of the grave consequences that came along with drug and alcohol use. It was 1983, I was a senior in an all girls Catholic High School. At this time, I was preparing myself to leave home for college. I excelled academically and fancied myself as a prestigious physician in the near future. My family saw my future as bright and promising. We were all excited as the opportunities poured in from the different colleges. Then crack cocaine entered into my life. I had been experimenting with marijuana and alcohol for a couple of years, but nothing too crippling. I thought all drugs were created equal. I had no idea that crack cocaine was destroying peoples' lives. I had no idea that people were losing their jobs, their homes, their pensions, their children and their lives. I had no clue what I was about to experience in my life. I had no clue that the first hit would change my life forever. I had no clue that all my desires, dreams and goals were about to be snatched away from me in a blink of an eye.

I was hooked after my first hit. I wanted more and more. I did not understand what was happening to me. I was spiraling out of control. Crack cocaine had me in its grips from the beginning. I smoked the pipe without impunity and with blinders on. The feeling was indescribably euphoric; I needed more. The next hit on the pipe was the only thing on my mind. Nothing else mattered. Cocaine came for me like a thief in the night. The bad part is, I did not even see it coming. It blindsided me and stole everything in my life that meant anything to me. Cocaine even stole my soul.

I started to change. What was once so important to me was now a distant memory. College

was no longer an option. The little naïve Catholic schoolgirl was no more. I was now experiencing the street life. I was now living in dope houses and doing whatever I could for the next hit of cocaine. My only desire at this point was to keep my pipe hot.

I had a "sponsor" in the streets. She showed me how to provide for myself financially while living on the streets. She said it was important for me to have my own money to buy my own drugs, cigarettes, and alcohol. She informed me that sleeping with the dope man was not the answer or the smart way to meet the needs of my cocaine habit. I followed her directions to the tee and I stayed high for years.

My life started to get progressively worse. I was getting raped, beat up, robbed, stabbed and having guns placed at my head on a regular basis. How did I get here? What happened to the life I had once knew? Where had all my dreams and goals gone? It felt as if I was living in another dimension, in a dark world of sots. Everyone was wandering around aimlessly, like zombies, looking and searching for the next hit of cocaine. I did not know how I ended up in this other dimension, but I wanted to get back to the real world. I felt like I would die soon; either by someone killing me or by busting my heart with an enormous hit of cocaine. I wanted to stop using cocaine but I did not know how. What happened to my desire to live?

I thought about a friend of mine that had smoked cocaine like me, she went to a treatment center and stopped. Surely if this worked for her, it would work for me. I reached out to her and she invited me to my first C.A. meeting. It was at 3801 in Los Angeles. I remember it being very dark and smoky, it looked like I was in a bar. The people seem so happy, they were laughing, and socializing with each other. I could not understand why everyone seemed so happy to be in a meeting of Cocaine Anonymous. They told me all I needed was a desire to stop using and God would do the rest, but

I did not have enough power to even generate a desire. I was broken, physically, mentally, and spiritually.

Thus started my bouts to treatment centers. Surely this would work for me. I was in 15 recovery homes (long term treatment six months or better), four detoxes (seven days) and two hospital programs (14-30 days), and still I could not stay stopped. Once I left treatment, I always went back to cocaine. I had so many ideas on how to stop using cocaine, but none of them worked. I felt so hopeless. I did not understand how others could stop and stay stopped but I could not. Still my desire for cocaine was stronger than my desire to stay in the rooms of C.A.

May 21, 1996 I finally surrendered to the idea that I was going to die a cocaine addict and there was nothing I could do to stop smoking. I entered treatment for the last time, not to stay sober, but to get some rest. I was physically tired, malnourished, disheveled, and weak. I knew that this was just a pit stop because that had been my experience for so long. I knew that my desire to stay stopped was not enough to change my life. I felt defeated. Cocaine was my master.

Then something happened while I was in treatment. I embarked upon the 12 Step process. I was sure this was not going to work for me, but I did not have anything else to do. Wow, this was the best thing that could have ever happened for me. What a blessing I have received by taking this journey. God was able to come into my life, my heart, my soul and save a wretch like me. I learned that the only requirement for C.A. membership is a desire to stop using, but to stay around here you must get into the 12 Step work. That is what was missing all those years I was going in and out of treatment, The 12 Steps.

I am so grateful to Cocaine Anonymous for introducing me to the 12 Steps, which introduced me to a God of my own understanding that saved my life. I thank God for the process of recovery that has rocketed me into the Fourth dimension of existence. I no longer live in a dark place. The

world is bright today and has so many new opportunities to experience. I continue to work the 12 Steps, work with others and be of service and my life continues to get better daily. I am a member of Cocaine Anonymous and I am so glad that I am a member when I say I am a member. I thank God daily that my desire is enough to continue to seek him and help others. My desire today is to live in a recovered state, which is a gift from God that I will cherish and nurture

IMPORTANT NOTICE FOR PERSONS WITH CRIMINAL RECORDS WHO PLAN ON ATTENDING THE 2018 WORLD SERVICE CONVENTION IN MONTREAL CANADA

The Fellowship of Cocaine Anonymous is preparing to hold their annual World Services Convention in Seattle over the 4th of July weekend at the Doubletree in Seattle Washington. At the end of that Convention there will be a presentation for the 2018 World Service Convention in Montreal, Ontario, Canada. Canada has stringent laws regarding Convicted Felons and persons that have DUIs and this article is designed to help our members with those challenges prepare for traveling to Canada and perhaps to other parts of the world (remember, the World Service Convention will be in Sweden in 2019). The time to begin the process is now because it will take some time and considerable effort.

Many of us have suffered the consequences caused by some of our choices and having a DUI or Felony on our record can give us some of the biggest headaches. There are several methods to have some of our rights restored. The Internet offers many assets that address these issues and give very helpful hints for us to reestablish our rights as citizens again.

There are several issues in Canada's immigration law that will restrict people with felonies and/or DUIs from entering into Canada and name them as "inadmissible." Some of those are; security risk, human or international rights violations, criminal history, health problems, financial problems, dishonesty with applications to enter Canada, failure to meet conditions in the Canada's immigration law, and a member of your family is not allowed into Canada. You can find a list of criminal offences in the [Criminal Code of Canada](#) and the [Controlled Drugs and Substances Act](#).

Any and all of those issues could make one inadmissible to Canada; you will not be allowed to enter. However, if travel to Canada is necessary, they may issue you a [temporary resident permit](#). "To be granted a TRP, the applicant will need to demonstrate a required need for entering Canada, such as work, an emergency situation, or a humanitarian/compassionate reason. "The goal of a TRP application is to demonstrate that the individual is not a threat to Canadian security during the period they will be in Canada, and to

convince the office that their reason for being in Canada during that period may be a benefit to Canada (for example, if the person is attending a work meeting and will be bringing business to Canada). The benefit of a TRP is that unlike Criminal Rehabilitation, it can be applied for at either a Canadian consulate or at any Canadian port of entry (borders, airports, etc.) Making the application at a port of entry will most likely be significantly faster than through a consulate – which often have long wait times. Wherever you file it, a TRP application can take up to six months for processing and a personal interview may be required."

If convicted of driving while impaired by alcohol or drugs, probable cause will be found to make you criminally inadmissible to Canada. As of March 1, 2012, you may be able to get a temporary resident permit for one visit without paying the \$200 processing fee (Canadian dollars).

Check with your local State authorities before booking travel, as every State has different paths to reestablish your rights. This will help make sure that when you arrive in Canada, a border services officer has enough information to decide if you can enter Canada. The officer will still check to make sure you are not inadmissible for other reasons.

Depending on the crime, how long ago it was and how you have behaved since, you may still be allowed to come to Canada, if you: convince an immigration officer that you meet the legal terms to be [deemed rehabilitated](#), or [applied for rehabilitation](#) and were approved, or were granted a [record suspension](#) or have a [temporary resident permit](#).

Most states have now passed laws to have felonies forgiven once all of the prescribed requirements are met. (Time Served, probation completed, fines paid, etc.) Please check with your individual state and local for their regulations.

MY STORY

When I first came into the rooms of Cocaine Anonymous, my sponsor gave me a few MUSTS, if I wanted to have him as my sponsor. I had to call him every day and if he didn't answer, I had to leave a message, I had to go to 90 meetings in 90 days (I went to 120 in 90 days ... some are sicker than others) and at 90 days I needed to go to the Hospitals & Institutions meeting. Although we were in different Areas, I had the choice of going in my own area, SFVCA or to the CALA Area (his area). I had told myself that I was only going to give C.A. 90 days of my undivided attention and then possibly go out because I wasn't so sure that I could stay clean AND sober with NO MIND ALTERNATING SUBSTANCES for the rest of my life ONE day at a time.

On or about my 90th day, at my sponsor's behest, I went to my first (SFVCA) H&I meeting held on the first Monday of the month at the church on Moorpark and Colfax. Since I had already been going to a number of C.A. meetings, I was familiar with many who were currently serving on the H&I Committee. I was welcomed at the H&I meeting as I had been at the regular meetings, and greeted by supportive messages such as, "here's where the winners are." "If you support H&I you are 85 times less likely to relapse." I didn't want to relapse and I've always wanted to be a winner, so it was natural to be impressed with this new meeting. At my first 'business' meeting of C.A. there seemed to be a lot of 'business' being done and a lot I didn't understand.

Just before the break, one committee member made the following comment. "We have only a few panels left, they are going like hot cakes so at the break come and see me and I'll get you a panel. Hurry, now don't let someone else get your panel."

Well, I only remember a flurry of people clamoring over the precious few panels that were left. (I know today looking back; it was only what it appeared to me) When I got over to him, there were only two panels left and so I took the fifth Wednesday at the Wayside Men's Treatment Center. Whoo hoo!! I

got a panel! I got a panel! As the night went on, I also was invited to join a few other panel leaders on their panels. I think I had one young person's mental ward at a hospital and the Salvation Army.

As the evening was closing someone made the comment that you needed only 90 days to speak on a panel but six months to be a panel leader. But, I was a panel leader and I had less than six months clean and sober. I raised my hand to explain that I had to give up my panel because I had less than six months. I also, was kind of glad, I didn't want that kind of responsibility and besides, I was probably going to go out soon, as that was my plan.

Well, those in charge who, in my opinion, were listening to the spirit of the law and not the letter of law asked me, "What panel do you have?" I responded, "The fifth Wednesday at Warm Springs." "Well, let's just see when the next fifth Wednesday comes up?" We looked at the calendar and it was two days after I turned six months clean and sober. "You mean I can have it even though I don't have six months now?" I asked hoping they would answer in the negative. "Well, if you stay clean and sober for the next three months, you have every right to be the panel leader. Plus you will get to go on a lot more panels and be a professional panel leader in three months." I had been given a sacred trust of this Fellowship. I, this drunken, crack smoking piece of crap was entrusted with an H&I Panel. If I kept my side of the bargain, three more months of sobriety. God was doing for me what, at the time, I couldn't do for myself.

I am so grateful for those H&I committee members who listened to the Spirit of the Sunlight and made me feel like I was a worthy and trusting human being. I am so grateful for H&I that has helped me maintain my sobriety and this Fellowship which I love with all my soul.

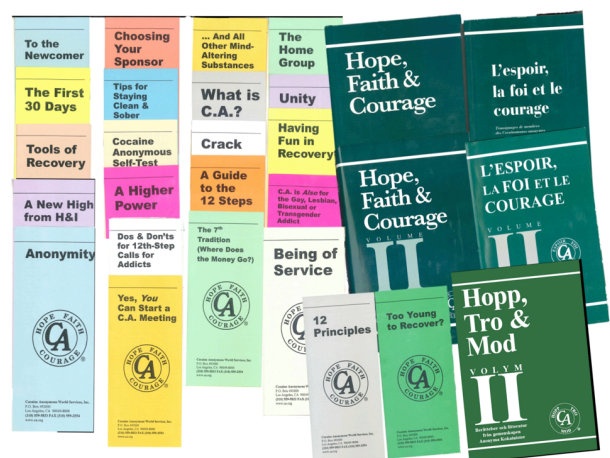

MY EXPERIENCE

Crenshaw, California, USA

I am a 12 year sober Japanese American, 66 year old addict, from the Crenshaw area of Los Angeles, California. Before being sober, I had been to jail, seen A.A. meetings in the 1970's, been thru recovery programs, and never had periods of being sober. January 2004, I did an unbelievable act. I turned myself in to the courts, while having two felony drug possession warrants over my head. Too tired and sick to continue, somehow I understood there wasn't an option and this was to happen sooner or later. After months in jail, I was allowed to go to a small recovery facility in Burbank called the "Victory House."

That first week there, I heard my story. A 6'4", 280 lb black man stood in front of the main meeting room at the facility, and talked about using from a young age, driving thru all the areas of Los Angeles to get drugs and smoking cocaine from the 1970's & 80's. He grew up where I grew up, did what I did. One year ago on February 1, his birthday, he was in jail realizing it was his thinking, his decisions which had landed him exactly where he was. WHAT!? I just celebrated my birthday on February 1 in jail and had the very same thought! How could he be telling my story so exactly? Obviously, he caught my attention, as did the process.

I found a sponsor that I could relate to, unbelievably a Japanese crackhead from Crenshaw! He introduced me to the big book of *Alcoholics Anonymous*, the 12 Steps and 12 Traditions and being of service. I learned early to stick with the winners. He brought me to his recovery family, as his grandsponsor gathered his sponsees and their sponsees once a month at a meeting they referred to as Generations. The very first meeting, one of them set me up for my first H&I panel speaking experience. I was so nervous, I spoke only about seven minutes, but a guy came to me at the end, and talked about relating to what I had said. I was touched and, because I had just heard my story, I knew the feeling.

I did panels in San Fernando Valley, going to their monthly business meeting, and it was there that I heard them say, 'Those who stay with H&I, stay clean!' and after returning to Crenshaw to help my mom, I got involved with H & I again. Since that time, I have been fortunate enough to hold the H&I chair for the Westside Hollywood District of Los Angeles for three years, been given an opportunity to run Holiday marathons for C.A. H&I at the Veteran's Administration in Westwood on Christmas and New Years long enough to develop great relationships with a number of veterans there. This year, I've been allowed the honor of chairing the World Service Conference H&I Committee, which has been another great learning experience. I cannot remember not being involved with H&I, and it appears they were right. I am still clean and sober and the experience keeps getting better!
